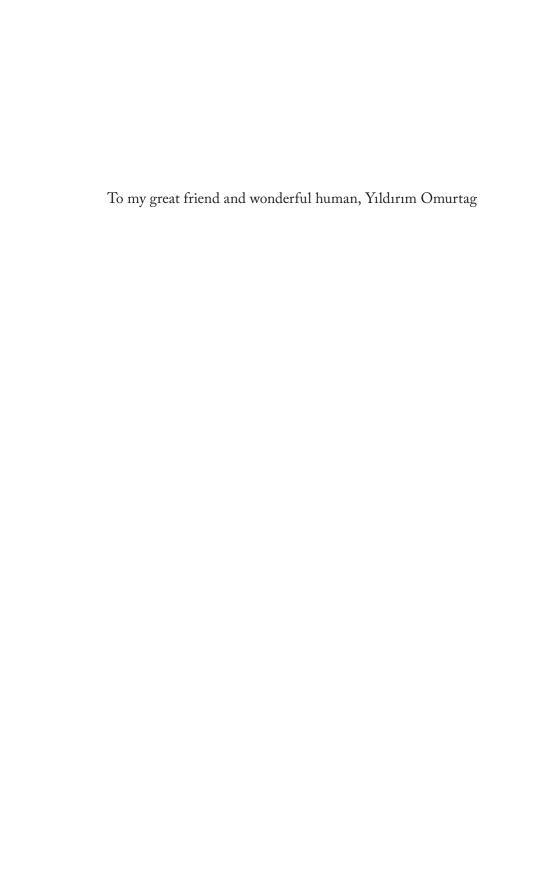

#### **Preface**

I felt the need to show how systematic strategic planning can be used in real-life scenarios even by unskilled professionals. Accordingly, I wrote this book with the aim to let this systematic methodology and its analysis tools, based on fundamentals, be easily understood and universally applied to any type of business.

Rather than explaining the methodology and its tools (which has already been done in my previous book titled *Systematic Strategic Planning*), the intention of this book is to show how to use this methodology in developing strategic plans. But, most importantly, you are taught how to identify in what circumstances you might use specific tools and also how to target them directly at achieving effective results.

This book is organized into parts as detailed in the following. The methods and techniques, case studies, and working forms presented will guide you in preparing a strategic plan for your existing or future business:

- Part I provides the overall framework and describes the systematic pattern of strategic planning.
- Part II demonstrates case studies that were prepared by my dear students. Most of the case studies are entrepreneurial

and are of new businesses. Though the cases do not use all the sections/steps and/or techniques of systematic strategic planning, they still reflect the basics of a typical strategic plan.

This book is written mainly for two groups:

- The first group includes professional strategic planners and students who are interested in strategic planning. This group may be skilled at making strategic plans but do not fully understand that a strategic plan for any business would involve variables specific to a particular business process. Their conventional approaches must be replaced by broader analyses and individual and factual analyses of specifics by group opinions and evaluation of convenience or preference.
- The second group are professionals—people not skilled in the techniques of strategic planning. This group includes such people as owner-managers of small businesses, managers who are generally familiar with strategic planning, and department heads who have jobs that they plan to do themselves.

The content of this book has been prepared using the results obtained from applying the issue at hand to different application environments and their cause-and-effect relations. This book is a supporting material for my previous book *Systematic Strategic Planning*. It has been designed to be specific, simple to understand, and easy to use.

I owe a great debt of gratitude to all the students who contributed their case studies to the development of this book.

Most of all, I am very thankful to Richard Muther for coming up with the systematic methodology for strategic planning and for his incredible innovation for planners, which is called *Planning by Design*.

### PART I

## Systematic Strategic Planning (SSP)

Before beginning with strategic planning, businesses must have articulated their *missions and visions*, and identified their basic *policies*.

A strategic plan outlines the path between the current status of business and the desired status to achieve. It helps the business to establish its objectives, goals, as well as the decisions to achieve these objectives and goals. It involves a long-term and prospective perspective.


A strategic plan provides guidance for the preparation of functional plans and business budget in such a manner that they reflect the objectives, goals, and grand strategies of the strategic plan during the implementation phase, as well as for basing resource allocation on priorities. Figure P.1 shows the before and after links of strategic planning.

Functional plans help in implementation of strategic plans by organizing and activating specific subunits of the business (marketing, finance, production, etc.) to pursue the business strategy in daily activities. The greatest responsibilities are in the implementation or execution of a strategic plan. Functional plans are more specific than a business strategy to guide functional actions taken in key parts of the company to implement business strategy. Figure P.2 shows the relationship between functional and strategic plans.

Systematic strategic planning (SSP) is the pattern of procedures by which an organization defines its current status, opportunities,



Figure P.1 Strategic planning—before and after.



long-term goals, and the strategies for which to achieve them. SSP is based on the principles of *PxD* (*Planning by Design*), which is generated by Muther (2011).

SSP consists of a framework of phases through which each project passes, a pattern of sections for straightforward planning, and the fundamentals involved in any strategic planning project. Figure P.3 illustrates SSP full version.

The techniques to be used for strategic planning should not be perceived as a procedure of systematic, and the techniques used should be continuously repeatable and modifiable depending on the characteristics of individual cases.

Certain working forms (in the forms of key documents and output) are used in applying the techniques in each section or steps of the SSP pattern.

In Phases II and III, the planning specialist follows a method of procedures to achieve alternative strategic plans.

In holdings/large businesses, the planning specialist uses Phase II in full SSP version to develop the overall strategic plan. The planning specialist may repeat Phase III of the full version to develop detailed strategic plans of each business/division of the holding/large business or use shortened SSP version instead if the business is small.

## Systematic Pattern of Strategic Planning

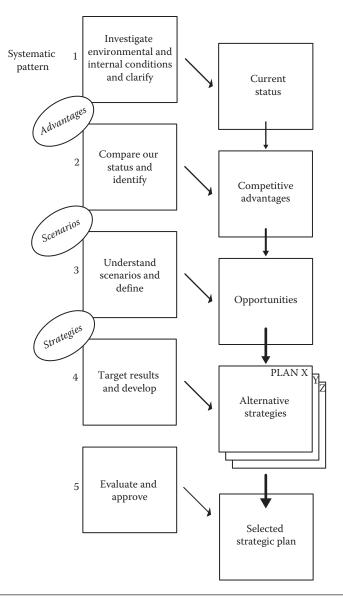


Figure 1.1 SSP—five sections.

Phases II and III are comprised of the five sections of systemic strategic planning (SSP) illustrated in Figure 1.1. For the sake of this book, only the first four sections are applied for the example cases; the fifth section is not explained as it has already been discussed in detail in my previous book titled *Systematic Strategic Planning*.

#### 1.1 Investigating Environmental and Internal Conditions

The aim of the first section of SSP is to answer the question "where are we?" This requires a comprehensive status analysis. Status analysis essentially covers the following assessments:

- Analysis of the internal structure of the organization (analysis
  of the duties and authorities, performances, problems, potentials, institutional culture, human resources, technology level,
  etc., of the organization)
- Environmental analysis (analysis of external conditions as well as the environment in which the organization operates and related parties—target group of the organization and parties affected negatively/positively by the organization's activities)
- Analysis of future developments and their impact on the organization

During and after status analysis, the internal strengths and weaknesses of the business, and the positive and negative developments originating from external factors are identified.

#### 1.1.1 Internal Analysis

When an internal status analysis is performed within the business, the past performance of the business is evaluated and its strengths

and weaknesses are put forth. The purpose is to identify the potential of the business taking into consideration its current performance and problems.

Diagnosing a business' key strengths and weaknesses requires the adoption of a disaggregated view of the business. Examining the business across distinct functional areas is one way to disaggregate the business for internal analysis purposes (see the Functional Approach form in Chapter 3).

Therefore, the business should examine past performance (see the Business History Summary Table in Chapter 3) to isolate key internal contributors to favorable (or unfavorable) results. What did we do well, or poorly, in marketing operations, and financial operations, and financial management that had a major influence on past results? Was the sales force effectively organized? Were we in the right channels of distribution? Did we have financial resources to support the past strategy? The same examination and questions can be applied to the business' current situation, with particular emphasis on changes in the importance of key dimensions over time.

Quantitative tools cannot be applied to all internal factors, and the judgment of key planners may be used in evaluation. Company or product image and prestige are examples of internal factors more appropriate to qualitative evaluation.

The considerations revealed by Functional Approach are grouped under various functional headings such as overall management, human resources, operations/technology, marketing, finance and accounting, and their distinction as things done well and poorly.

#### 1.1.2 Environmental Analysis

Intention of environmental analysis:

- To determine the developments and trends in the macroeconomical (demographic, economical, judicial-political, technological, sociocultural) environment that effects the business and its industry at most
- To understand the powers that effect competition in the industry (new businesses, customers, suppliers, substitutes, competitors, government, financial institutions, etc.)
- To foresee the trends that these powers would create in the industry

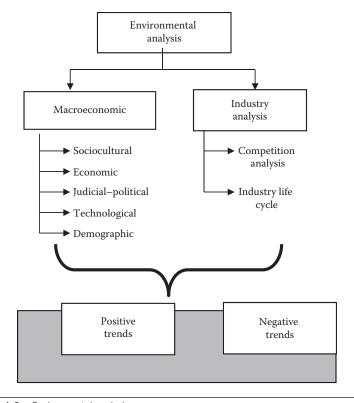


Figure 1.2 Environmental analysis.

Environmental analysis, which is illustrated in Figure 1.2, considers the general trends in the world, changes in the environment in which the business operates, and particularly the expectations of the group served by the industry. Environmental analysis does not only identify

the current status but also lays the basis for forecasting the change of scenarios in the future. If a business that is in interaction but cannot control many processes in the environment fails to follow up this change, then strategic planning would not make much sense. Key considerations in environmental analysis are as follows:

- Current global status and development trends in the field of the business
- Current domestic status and development trends in the field of the business
- Critical issues that closely concern the business among the basic trends and problems in the world and in the country; how and in what direction these issues will affect the industry in which the business operates
- Basic negativities and uncertainties faced by the business due to the conditions of the industry

1.1.2.1 Macroeconomic Analysis Macroeconomic variables are the variables that affect businesses and their industry and are not under the control of businesses. Macroeconomic variables are

- Demographic
- Economic
- · Judicial-political
- Technological
- Sociocultural

The variables to be evaluated in order to compose changes and developments are specified later. This review should primarily be conducted at a global scale, and then at regional and country scales.

After collecting information about the present state, efforts must be made to identify trends in variables and the continuation of these trends. The purpose is to ascertain the impacts of variables in the macroeconomic environment on stakeholders.

In order to analyze the effects of trends and developments within these variables on the industry, the *Macroeconomic Analysis form in Chapter 3* can be used. While composing this matrix

- On vertical axis—trends determined on variables
- On horizontal axis—stakeholders of business
- On elements of matrix—the anticipated effects of trends on the stakeholders should be input

The macroeconomic analysis table summarizes the status of the variables with respect to customers', governments', financial institutions', suppliers', shareholders', and employees' points of view. If the macroeconomic factors

- Turn into a better condition, then mark as +
- · Remain unchanged, then mark as blank
- Turn into a worse condition, then mark as -

1.1.2.2 Competition Analysis Porter (1998) stated that if a business is producing a product or service with market considerations like global and domestic market conditions, development/evolution trends of the demand for the subject product and/or service, price movements,

changes in quality and standards, competition, etc., are laid down as a result of a comprehensive analysis of the powers in the industry.

The powers that affect a business at most are the groups that create competition within the industry:

- Rivalry among existing companies
- Threat of potential new entrants
- Bargaining power of customers
- Threat of substitutes
- Bargaining power of suppliers
- Bargaining power of other stakeholders (government, trade unions, financial institutions, etc.)

The influence of these powers determines the strength of competition within the industry. In an industry where the power of these groups is high, the potential of profitability will be low. When one of these groups has a higher power, this will have negative implications for the industry, whereas a lower power will have positive implications. Now, let us analyze these powers (*see the Competition Analysis form in Chapter 3*):

#### Rivalry

Competition in an industry is high if

- The number of active businesses is high
- The growth rate of the industry decelerates or accelerates rapidly
- The characteristics of products/services are not very different
- · The fixed costs are high
- The cost of leaving industry is high

#### Threat of potential new entrants

Entry barriers are high at the rate

- Of having low costs due to the size of the companies within the industry
- Of having brands within the industry
- · Of having high investment requirement
- Of accessibility to distribution channels being hard

- · Of having high learning curve effect
- Of having various limitations by the government for the new entrants

#### Bargaining power of customers

#### Customer is powerful if

- It purchases in large quantities of the products/services of the supplier
- It has the potential of producing products/services by vertical integration
- There are alternative suppliers
- The cost of changing supplier is not high
- It is sensitive to price and service variations
- The purchased product/service does not bear an importance for its production/operation

#### Threat of substitutes

Substitutes are products/services that cover the same requirements in different ways. In industries where substitutes are plenty and the customers have low product-changing costs, companies can face with less profit.

#### Bargaining power of suppliers

#### Suppliers are powerful if

- The industry is composed of limited suppliers
- Their products/services are unique and exclusive
- There is no substitutes in the market
- They have the potential to compete with the current customers through vertical integration
- The purchases compose a small portion of their income


The results of analyses conducted in the light of these and similar considerations will be given in summary (Porter 1998):

• Each force needs to be evaluated in terms of—does it make the market

- High
- Moderate or
- Low attractiveness?
- Each force needs to be evaluated in terms of its relative importance

When the industry changes significantly, it is frequently not because of one competitive force but because of changes to two or possibly three forces combining together (see Evaluating Competitive Forces and Competitive Forces Status forms in Chapter 3).


Figure 1.3 Industry life cycle. (Reprinted from Vernon, R., Oxf. Bull. Econ. Stat., 41(4), 255, 1979.)

1.1.2.3 Industry Life Cycle Vernon (1979) stated that each industry passes through the phases of introductory, growth, maturity, and finally regression. The phase that the industry is in facilitates the estimation of impacts and trends of powers defined in competition analysis. Figure 1.3 shows the industry life cycle.

#### 1.2 Identification of Competitive Advantages

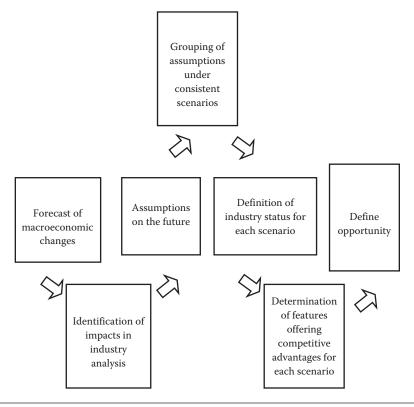


**Figure 1.4** Competitive advantages and success factors. (Reprinted from Pearce, J.A. and Robinson, R.B., *Strategic Management: Formulation, Implementation and Control*, McGraw-Hill Higher Education, Columbus, OH, 2011.)

The organization's strengths and weaknesses are compared with the key factors in the market development phases, capacities, and resources of main competitors and the industry's success factors, to identify competitive advantages. Figure 1.4 summarizes the development of a business profile (Pearce and Robinson 2011).

The result of the second section should be a determination of whether key internal factors are as follows (see the Comparison with Main Competitors and Industry Average and Competitive Advantages—Success Factors—Key Vulnerabilities forms in Chapter 3):

- 1. *Competitive advantages*: Factors providing the business with an edge compared to its competitors, and therefore, key factors around which to build the business' strategy.
- 2. Basic business requirements: Factors that are important capabilities for the business to have but are also typical of every

- viable competitor; do not represent a potential source of any strategic advantage.
- 3. Key vulnerabilities: Factors on which the business currently lacks the necessary skill, knowledge, or resources to compete effectively. This assessment is also a key input because businesses will want to avoid choosing strategies that depend on factors in this category, and businesses usually target key vulnerabilities as areas for special attention so as to remediate and change this situation.

#### 1.3 Understand Scenarios and Define Opportunities

Figure 1.5 shows the procedure of identifying opportunities.

#### 1.3.1 Scenarios

First of all, the scenarios to be created by trends revealed by environmental analysis for the industry must be developed; that is, alternative scenarios must be developed for the future. Thus, assumptions are grouped under various scenarios, their potential positive and negative impacts on the industry are identified, and the potential status in the industry is defined. Scenarios are as follows:

- Internally consistent views of the future
- · Focus on discontinuity and change
- Explore the impact of the change on key players and how they respond to the environment

The opportunities and threats that may be offered and posed for the organization by positive and negative scenarios revealed by scenario analysis must be identified. Furthermore, identification of the organization's competitive advantages and weaknesses relative to competitors and industry standards could lead this section to an efficient result.

In short, in order to identify opportunities and threats, the organization's competitive advantages and weaknesses must be matched with potential positive (attractive) and negative (risky) scenarios that may be encountered in the industry.

1.3.1.1 Assumptions on Future Assumptions imply the external factors that are not under the direct control of the business preparing the strategic plan but that can affect the progress and success of the strategic plan. After reviewing sociocultural factors, technological factors, political environmental, legal conditions, macroeconomic factors, and variables originating from international system in the environmental analysis, the tendencies of related parties such as competitors, customers, and suppliers must reflect onto the systematic pattern of strategic planning as assumptions.

First, key external variables are identified. Assumptions are made for the values of quantitative and qualitative variables (through brainstorming or statistical models). Brainstorming and/or statistical models are popular estimation techniques:

- Brainstorming is a non numerical estimation technique.
   While conducting scenario analysis, instruments like participatory meetings bringing together various groups concerning the business are used. For the efforts to be made in this scope, it is possible to outsource specialized services, such as the use of facilitators (moderators) who will neutrally facilitate participatory meetings.
- Statistical models are numerical techniques including relations and other econometric models. However, it is based on historical data, and error margin increases as the structure of relations changes in time.
- 1.3.1.2 Grouping of Assumptions Position the key assumptions that underpin an issue. Write the assumption in shorthand on a yellow post-it and position relative to others on the grid. Test out relative and absolute positioning (see the Certainty-Importance Grid in Chapter 3).
- 1.3.1.3 Generating Scenarios Generate scenario stories by testing out judgments and identifying interdependencies (see the Developing Alternative Scenarios form in Chapter 3):
  - 1. Prepare a list of basic assumptions.
  - 2. Rank the assumptions according to probability of actualization and importance.
  - 3. Convert the classification of each assumption into quantitative values (A = 4, E = 3 ...); multiply the values, and select two or three assumptions with the highest value.
  - 4. Use the selected assumptions individually or as a group to diversify the basic scenario.

#### 1.3.2 Opportunities and Threats

The opportunities and threats that may be offered and posed for the business under the positive and negative scenarios to come out from scenario analysis must be identified. Moreover, determining the strengths and weaknesses of the company compared to its competitors will be able to carry the analysis to a satisfactory result. In short, competitive advantages and weaknesses of the business need to be matched with the potential positive (attractive) and negative (risky) scenarios in the industry.

While developing strategies for the future, opportunities will have a significant influence while threats will be monitored closely by the business and measures will be taken against these threats.

Opportunities, by definition, arise in cases where the unresolved problems and unsatisfied expectations and needs are identified for use of products and/or services in the market, and if solutions can be produced for these.

By testing out total market attractiveness of each positive scenario, you would be able to screen out investment opportunities even before considering what kind of competitive strengths you might be able to attain. The *attractiveness* is the net benefits less the costs (not just the benefits).

Besides market attractiveness of a scenario, to position a business effectively on the GE grid, you also need to take some view of its competitive position with respect to the particular scenario. The following 10 key criteria will usually suffice:

- Brand, image, and reputation
- Simplicity of product/market focus, or alternatively a relevant and broad offering
- Relative market (or niche) share
- Product and service performance
- Distribution channels
- Cost base
- · Responsiveness (but this does not mean reactiveness)
- Technical and nontechnical competencies
- · Financial strength
- Management skills

The aforementioned factors can be scored as *strong*, *average*, *or weak*. Also, the relative importance of the factors can be assessed by weighting some factors as being more important than others. Rasiel (1999) stated that the GE Grid (*see the Business Opportunities form in Chapter 3*) enables you to

 Position a business, having determined market attractiveness of a scenario and competitive position of a business with respect to the particular scenario

- Evaluate business opportunities
- Reposition a business (from right to left on the GE grid, or even [by shifting the business' market focus] diagonally northwest)
- Challenge the adequacy of investment to achieve such a repositioning (both long-term investment and revenue costs with longer-term benefits)
- Compare your positioning with other key competitors operating in the same or different market segments

Not all opportunities are equally valuable. A business with limited resources cannot pursue every opportunity with which it is faced. It must select those opportunities that are going to be the most rewarding. The key decisions in screening and selecting opportunities relate to the size of the opportunity, the investment necessary to exploit it, the rewards that will be gained, and the risks likely to be encountered. Specifically, the decision should be based on the answers to the following questions (see the Selection of Opportunities—Prioritization form in Chapter 3):

- Market attractiveness: Is the market (or segment) inherently attractive (consider key growth drivers and competitive forces)?
- *Competitive advantage*: Are we likely to have (and be able to sustain) a competitive position?
- Financial attractiveness: Are we likely to make enough money out of it?
- *Implementation difficulty*: Do we have the capability, resources, and commitment to implement it effectively?

#### 1.4 Strategic Objectives, Main Goals, and Main Strategies

#### 1.4.1 Strategic Objectives

Strategic objectives are the conceptual results that the business aims at achieving within a certain timeframe. Strategic objectives and main goals answer the question "what do we want to achieve?" within the SSP.

#### 1.4.2 Main Goals

Main goals are specific and measurable subobjectives specified for achievement of strategic objectives. Unlike strategic objectives, goals are expressed in quantifiable terms and cover a shorter term. Multiple goals may be established to achieve a strategic objective.

Main goals are the qualitative and quantitative expression of strategic objectives within a defined timeframe (*see the Strategic Objectives—Goals form in Chapter 3*). For this reason, they are measurable subobjectives intended for outputs to be achieved. Goals should be expressed in terms of quantity, cost, quality, and time.

#### 1.4.3 Main Strategies

Strategies are instruments for achievement of long-term goals. It is a course of action selected from a series of options in order to achieve a goal established against uncertainties.

Alternative strategies are developed by searching for an answer to the question "what should businesses do to be competitive and lasting in their own industries and markets?"

Determination of a suitable strategy for a business begins in identifying the opportunities and risks in its environment. This (discussion) is concerned with the identification of a range of alternative strategies, the narrowing of this range by recognizing the constraints imposed by business capability, and the determination of one or more strategies at acceptable levels of risk. While evaluating the opportunities defined on the basis of analyses conducted, various strategies we can implement come out:

- You should have a single strategy for a single opportunity.
- If there are multiple opportunities, you can have multiple strategies.

Based on using both the techniques of generic competitive strategies and components of strategy, the main strategy(ies) can be identified. Accordingly, this will lead you to the selection of the corresponding grand strategy(ies.)

1.4.3.1 Generic Competitive Strategies The fundamental basis of above-average performance in the long run is sustainable competitive advantage. There are two basic types of competitive advantage a business can possess: low cost or differentiation. Any strengths or weaknesses are ultimately a function of relative cost or differentiation (Porter 1998).

The two basic types of competitive advantage combined with the scope of activities for which a business seeks to achieve them lead to three *generic strategies* for achieving above-average performance in an industry (*see the Generic Competitive Strategies form in Chapter 3*).

Each involves a different route to competitive advantage, combining competitive advantage sought with the scope of the target. The specific actions required for each generic strategy vary widely from industry to industry. Broad target is defined as one that

- 1. Covers a great diversity of customer needs and market segments
- 2. Covers a wide and perhaps complex range of products and services
- 3. Covers both (1) and (2)
- 1.4.3.2 Components of Strategy In conjunction with its objectives, the firm may choose one, two, or all of the strategy components with respect to its current product-market position (Ansoff 1970). This can be illustrated by means of a matrix (see the Components of Strategy form in Chapter 3).
- 1.4.3.3 Grand Strategies Grand strategies, often called business strategies, provide basic direction for strategic actions. Grand strategies indicate how long-range objectives will be achieved. Thus, a grand strategy can be defined as a comprehensive general approach that guides major actions:
  - Are we going to stay in the same ring of value chain? Are we going to continue doing the same work with the same system? (Constancy.)

- Are we going to enter new business areas with additional functions, products, and/or markets? (Expansion.)
- Are we going to leave the business completely? Are we going to leave some of the business? (Reduction.)

Any of the 12 principal grand strategies (Pearce and Robinson 2011) serves as the basis for achieving major long-term objectives of a business, identified according to the techniques of generic competitive strategies and components of strategies:

- Concentration
- Market development
- · Product development
- Innovation
- · Horizontal integration
- · Vertical integration
- · Joint venture
- Concentric diversification
- Conglomerate diversification
- · Retrenchment/turnaround
- Divestiture
- Liquidation

## Sample Outline for Strategic Plan

A good strategic plan is between 25 and 50 pages long and takes at least 6 months to write:

Vision Mission Basic Policies Executive Summary

This section should summarize the most important subjects of strategic plan and interconnect various sections. Begin with a two-page or three-page management summary of the venture. Include a short description of the business and discuss major goals and objectives. Describe company operations to date, potential legal considerations, and areas of risk and opportunity.

## Strategic Plan

1. Status analysis

The status analysis section is expected not to exceed three pages.

## Environmental Analysis

This should consider external factors such as demographic, economical, legal-political, technological, and social changes, market dynamics, customer expectations, competitive conditions, strategies and objectives of competitors, suppliers, substitutes, etc.

- Macroeconomic analysis (global, national)
  - Demographic variables
  - Judicial-political variables
  - Economic variables
  - Sociocultural variables
  - Technological variables

The goals intended to be achieved during the next 5 years must be mentioned for each year, taking into consideration the following headings:

  - Regional concentration
  - Planned strategic partnerships
  - Alliances, merging and acquisitions, etc.
  - Market goals
  - · Financial goals, etc.

- Operational goals:
  - Technological improvements
  - Organization, etc.






Figure 4.1 Industry life cycle.

#### 5.2 Environmental Analysis

#### 5.2.1 Macroeconomic Analysis

Macroeconomic analysis summarizes the status of the variables with respect to customers', governments', financial institutions', suppliers', shareholders', and employees' points of view.

On the *demographic* side, population growth rate has a low impact on the IT business environment.

On the *economic* side, growth rate, interest rate, exchange rate, and inflation rate are the factors that have a high impact on the IT business environment.

On the *political* side, government regulations and policies that have a huge impact on IT operations may include trade and labor laws, tax policies, environmental laws and regulations, trade restrictions, commercial tariffs, and infrastructure and development policies. 


Figure 5.1 Industry life cycle.

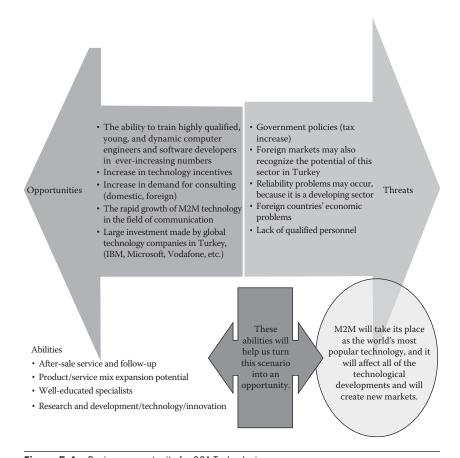




Figure 5.5 Components of strategy.

Tchibo is a retailer of food and nonfood products. The Tchibo shops are a three-in-one-store model, a unique combination of coffee shop, retail store, and coffee bar. The Tchibo shops offer an all-in-one experience. The nonfood product range of Tchibo includes kitchenware to leather jackets. The concept of *every week a new experience* makes the customer curious to look around, experience the new theme, and purchase some useful money-for-value consumer goods.

The primary product that Tchibo has a good reputation with is coffee. The company engaged in distribution of specialized coffee beans. Tchibo sells the products via its website and mail orders and in over 60,000 retail outlets spread across the globe. The company also sells its products at franchise shops and supermarkets. Tchibo has around 40,000 outlets in Germany and 1,300 stores in 60 countries.

In 2006, the company entered the Turkish market by opening its first Turkish Tchibo shop in Europe's largest shopping mall, Istanbul Cehavir. Following a successful market entry, distribution was swiftly expanded to over 30 Turkish shops. There are now Tchibo shops in Germany, the United Kingdom, Austria, Switzerland, Slovakia, Czech Republic, Russia, Poland, Romania, Hungary, and Turkey.

#### **Basic Policies**

Our employees are rightly expected to possess a high degree of social and ethical competence. Therefore, as we go about our daily tasks, the following principles serve as a minimum standard of conduct:

We bear a responsibility to the people in our company.
 Employee promotion and motivation are very important to us.

- People in many different countries trust in the quality, safety, and excellent value for money provided by Tchibo's products.
   We strive to be worthy of this trust and see customer satisfaction as one of our top priorities.
- Each employee is responsible for ensuring that human rights and fundamental social standards are not violated in their spheres of jurisdiction and influence. This applies, in particular, for working conditions at our suppliers and business partners.
- We see environmentally conscious action not only as a corporate obligation but also as an important condition for sustained, healthy growth.
- We are engaged in community projects in order to improve the social conditions in those countries in which Tchibo does business.
- The implementation and evolution of these values calls for an ongoing critical questioning of one's own position.

#### 6.1 Environmental Analysis

## 6.1.1 Macroeconomic Analysis

6.1.1.1 Demographic Turkey has a high population, and this is the third largest population in Europe with about 77 million people. It is slightly growing every year. The greatest part of the population lives and works in the western part of Turkey. Regions of Turkey with the largest populations are Istanbul (+12 million), Ankara (+4.4 million), Izmir (+3.7 million), and Bursa (+2.4 million). An estimated 70.5% of the population lives in urban centers.

6.1.1.2 Judicial—Political Turkey's constitution governs the legal framework of the country. It sets out the main principles of government and establishes Turkey as a unitary centralized state. Turkey is a member of the United Nations, the OECD, the OIC, the OSCE, the ECO, the BSEC, and the G-20 major economies. In 2008, Turkey was elected as a nonpermanent member of the United Nations Security Council. Turkey's membership of the council effectively began in 2009.

The first domestic franchising in Turkey started with Turyap in 1985, and the first foreign franchising started in 1986 with

McDonald's. Then, the franchisors have especially developed four categories: clothing, real estate, transports, and fast food.

Franchising in Turkey can trust in UFRAD (National Franchise Association): according to some statistical data from UFRAD, there are about 100 franchisors and 1500 franchisees working in Turkey. As there is no specific law to regulate franchise, the agreements between the parties establish directly all the contents in the trade-off and the approval of General Directorate for Foreign Investment (GDFI) is required if the trade-off involves foreign companies. Usually, the royalty is around 5% on-sold for food and beverages, but this percentage is expected to be higher for other categories.

#### 6.1.1.3 Economic

- Exports are \$115.3 billion f.o.b. (2007 est.).
- Commodities are apparel, foodstuffs, textiles, metal manufactures, and transport equipment.
- Partners are Germany, 11.3%; the United Kingdom, 8%; Italy, 7.9%; the United States, 6%; France, 5.4%; and Spain, 4.4% (2006).
- Imports are \$162.1 billion f.o.b. (2007 est.).
- Commodities are machinery, chemicals, semifinished goods, fuels, and transport equipment.
- Partners are Russia, 12.8%; Germany, 10.6%; China, 6.9%; Italy, 6.2%; France, 5.2%; the United States, 4.5%; and Iran, 4% (2006).

The main goods that Turkey exports are textiles, cotton, clothing, glass, oils and other fuels, iron and steel, precious stones, pearls, tobacco, and foods. Germany, Italy, France, the United Kingdom, and the United States are the leading countries to which Turkey exports bulk of its goods.

The main items that Turkey imports include machinery, iron and steel, aircraft and associated products, mechanical appliances, electrical equipment, and pharmaceuticals. The United States, Italy, Germany, Russia, France, the United Kingdom, and Switzerland are the main countries from where Turkey imports the bulk of the goods.

In order to negate the effects of worldwide recession and reducing figures of its exports to the European countries, Turkey is now

looking forward to expanding in new markets. Turkey is now exporting to several countries in the Middle East, Central Asia, and Africa.

There is an observation about Turkey's trade relations that the most intensive one is with Germany in consideration of Turkey's bilateral economic and trade relations with foreign countries. In 2009, Germany imported goods, \$14 billion, to Turkish and German states in first rank places as well as in previous years. The most significant product groups traded between Germany and Turkey are *knitted apparel*, accessories, machinery, equipment, and tools.

6.1.1.4 Sociocultural Turks are known as enthusiastic coffee drinkers. Even the formation of culture around coffee and cafés dates back to sixteenth-century Turkey. Cafés in Western Europe and the Eastern Mediterranean were traditionally social hubs. Drinking coffee is the most common social activity for Turks. This is part of the Turkish culture and can be observed in leisure time and during work. Drinking coffee is an accepted form of relaxation and social conduct. Anyhow, the annual per capita consumption of coffee of Turkey in 2008 is 0.4 kg. This is way below Finland, which is 12 kg. But in the last 2 years, according to the growth of the young population and coffee chains, coffee consumption is increasing every day.

6.1.1.5 Technological Technology is a trend that exists almost in all sectors. It is important for households as well. The demand for functional kitchen utensils and coffee machines is increasing in markets where participants generally need easiness in their daily life.

#### 6.1.2 Competition Analysis

6.1.2.1 Rivalry There are no direct competitors because Tchibo's concept is unique worldwide due to its special three-in-one-store model and the week concept. However, the products that Tchibo offers have many indirect competitors.

Starbucks: Starbucks is the largest coffeehouse chain company in the world with more than 15,011 stores in 44 countries worldwide. The Starbucks business concept operates with Starbucks-owned stores and licensed franchise stores. Starbucks keeps expanding to foreign markets: every day an average of seven new Starbucks stores open.

The Starbucks assortment covers different kinds of brewed coffee, espresso, cappuccino, hot and cold drinks, as well as roasted coffee beans, coffee mugs, and other coffee equipment. The snack assortments range from pastry over sandwiches to salads. Starbucks has several joint ventures and therefore licensed locations in airports, theme parks, grocery stores, hospitals, and university campuses. The mission of Starbucks is to create a third place between home and work. In 2003, Starbucks opened the first store in Turkey; today, there are more than 100 stores in Turkey (2009 Starbucks).

Gloria Jean's: Gloria Jean's Gourmet Coffees is one of the largest mall-based retailer of specialty coffees in the world. Their first store opened in 1979. Today, there are over 1000 stores in 40 countries with plans to expand annually. Gloria Jean's Gourmet Coffees serves almost 200 various drinks that are made with special coffee beans. In Turkey, Gloria Jean's has stores in Istanbul, Ankara, Izmir, Eskisehir, and Bursa.

*Kahve Dünyası*: The number of coffee shops reached 20 stores from Istanbul to Antalya. Its primary product is Turkish coffee. Besides coffee, they also offer handmade chocolates of their own production, which is sold under the name of Chocolate World.

*Boyner*: Boyner is Turkey's biggest department store chain, with 28 multistores, 11 concepts, and 10 outlet stores nationwide. The company was established in 1981 in Istanbul. The revenues reached 521.5 million TL in 2009. The total sales area was in 2009: 9.588 m<sup>2</sup>. Boyner department stores offer clothing, home furnishing, consumer electronics, household appliances, and more.

*YKM*: YKM was the first department store in Turkey and was established in 1950. YKM offers all products a family needs, from clothes to cosmetics and personal care products and technological products to electric home appliances and home decoration. YKM caters to the many needs of 35 million visitors per year with its 58 stores in 32 cities, over 4000 employees, more than 1000 providers, over 1100 brands, 150,000 kinds of products, and over 125,000 m² sales area as of 2009. YKM is the only member of IADS (International Association of Department Stores) representing Turkey.

*Migros*: Migros opened its first store in Beyoğlu at the fish market in 1957. Migros has a total of 1941 stores with 357 Migros, 264 Tansaş, 1.269 Şok, 11 Macro Center, and 10 5M in 73 cities in Turkey and

- 30 Ramstore stores abroad. In 2009, the revenue was 5,073,746 TL (thousand).
- 6.1.2.2 Suppliers Most of the products are produced in China, and the Chinese manufacturer market is highly competitive. This freedom of choosing a producer keeps the bargaining power of the suppliers low.
- 6.1.2.3 Customers The current buyers are households in several European countries who are searching for great coffee taste at a fair price and useful value for money. Products are for all ages and income levels. Although the product range is not gender-related, it should be considered that the majority of the buyers will be women because they mostly do the family shopping. Potential buyers could be Turkish households.

Buyers choose products because they look for excellent quality at a fair price. They want great coffee taste and the experience of the *every week a new experience* concept. Consumer goods are for use in daily life. Consumer goods are innovative, creative, and useful and should enrich the life of the customer.

- 6.1.2.4 Substitutes Consumer goods and coffee beverages can be bought in many different places. Both of these markets are highly competitive, and the consumer has different options to fulfill their needs.
- 6.1.2.5 New Arrivals A few firms control most of the market share and have the power. That makes it relatively difficult for new entrants. However, the franchise sector is growing in Turkey and different concepts from all over the world could be established.

# 6.1.3 Industry Life Cycle

There are up to 1000 aromas in a single coffee bean that can be released through the roasting process. Each region-specific raw coffee type requires special roasting conditions to develop its individual taste and aroma profile in an optimum way. Specialty coffee is a segment of the coffee industry. This term is used to describe beans of the best

flavor that are produced in special microclimates. Specialty coffee is commonly used to refer to gourmet coffee. Specialty coffees are grown in special and ideal climates and are distinctive because of their full cup taste and little to no defects. Their unique flavors and tastes are a result of the special characteristics and composition of the soils in which they are produced.

The specialty coffee segment is the most rapidly growing portion of the coffee industry. In the United States, specialty coffee has increased its market share from 1% to 20% in the last 25 years. To promote and self-regulate the industry, growers, exporters, roasters, retailers, and equipment suppliers have established trade associations. These associations exist in both coffee-consuming and coffee-producing countries.

According to the National Coffee Association, 49% of Americans aged 18 or older drink some type of coffee beverage daily, and many of them wait in lines at specialty coffee retailers to get their fix. The cafe segment of the specialty coffee market, including cafes, kiosks, carts, and coffee bean roaster/retailers, continues to grow. Specialty coffee (Starbucks, Tchibo, etc.) franchises are increasing day by day. Recently, specialty coffee consumption has moved toward the homes, where high-quality whole beans has become an important aspect.

## 6.2 Internal Analysis

# 6.2.1 Marketing

6.2.1.1 Sales Channel Tchibo uses a multichannel distribution in order to offer the products and services as convenient as possible for its customers.

Shop in shop (special retail partners): Tchibo has many concession partners and Tchibo products are sold in bakeries, supermarkets, drugstores, tobacco shops, hardware stores, and photo shops. A shop-in-shop concept is used in order to create the right brand awareness. Approximately one-third of all special retail partners offer the every week a new experience and a coffee bar service. For each sales outlet, individual sales solutions are developed. Tchibo supports the retail partners with several services, for example, promotion material. Furthermore, a good cooperation with big supermarkets provides Tchibo with a well-spread distribution network.

Direct (mail order business and e-commerce): Customers can order nonfood products and the coffee range via the mail order magazine published monthly. The four nonfood themes of the month and the coffee range are represented in the magazine. Moreover, customers can order the coffee range, the current consumer goods of the week and the last 3 weeks, and special offers over the Internet. Tchibo has its own online shops for Turkey, as well as an EU online shop.

6.2.1.2 Products and Services Tchibo offers a combination of coffee and well-priced, quality consumer goods. Tchibo sells two kinds of products.

Food products: The core business of Tchibo is coffee. The coffee expertise and the quality of the brand are well known and appreciated among customers. The coffee range goes from all classic roasted to instant coffees. The tastes vary from decaffeinated to espresso.

Nonfood products: Tchibo has created a worldwide unique and successful concept. Tchibo's idea and slogan is every week a new experience. Each week a new theme is created and around this theme Tchibo offers approximately 30 consumer good products that are exclusively made for the company. The themes suit the seasons and complement each other. The weekly changing range of products makes the customers return on a regular basis.

6.2.1.3 Image and Quality Another important core feature is the value for money and quality concept. Tchibo offers good quality at a fair price. Over the years, Tchibo has built a trust relation with their customers. As stated in the mission statement, Customer satisfaction and living up to the trust our customers place in us are the top priorities of Tchibo. Tchibo products have high standard in terms of materials, durability, functionality, manufacture, and safety.

All items are exclusively produced for Tchibo. Before the products are offered to their customers, Tchibo makes sure that they comply with Tchibo's safety and quality standards.

6.2.1.4 After-Sale Service Further services, which come with the products, are a 2-year warranty and a 3-year guarantee for technical products and zips, repair or product replacement service, and the right of return.

#### 6.2.2 Production/Operations

Tchibo develops some 2000 products a year: footwear, swimwear, clothes, furnisher, stereos, etc. At Tchibo, a team of product managers, buyers, marketing professionals, and quality developers are responsible for the product idea, its planning, and its execution. There is a team for the areas of bath & home, women's clothing and accessories, and children & outdoors.

Tchibo develops each product and is produced exclusively for itself. Tchibo contracts a make-up manufacturer and takes on the responsibility of distribution from the manufacturer country to its own stores and depots within other stores. The manufacturers of raw materials are subcontractors to the first tier supplier of Tchibo.

The major production countries are currently Bangladesh, China, Pakistan, India, Turkey, Laos, and Vietnam. Then, these products are tested by their in-house testing department as well as by independent laboratories.

#### 6.2.3 Personnel

Tchibo employed a total of 8465 employees in 2009, including trainees and management trainees. There are a range of job positions including brand, sales, and marketing manager, of which 5358 were employed part time, mainly in more than 900 shops.

- 6.2.3.1 Labor Relations Employees at Tchibo are paid strictly according to performance-based criteria as set out in the job requirements.
- 6.2.3.2 Employee Skill and Training In Tchibo, employees should always be able to cope with increasing demands, thus supporting them with a comprehensive range of further training measures. At Tchibo, they are all constantly required to cope with new challenges. This is where it supports its employees through a personnel development program in order to support the employees actively and help them to recognize and promote their individual potential. The program includes skills training, management development, and foreign languages.

In 2007 and 2008, expenditure on training exceeded €900,000, while in 2009 around €1,100,000 was invested in training and further development for Tchibo employees.

#### 6.2.4 Finance and Accounting

As stated in the financial report of 2006, revenues exceeded €9 billion in 2006 for the first time, which is a total increase of 3%. Furthermore, in 2005, the revenues were €4 billion, while in 2006, only €3.9 billion. This is a decline of 2%, which happened due to a highly competitive German market and investments in new business areas.

In 2006, the earnings per share amounted to €178.73; in the previous year, it was €75.70. As the ratio gets higher, the stock value increases. Foreign revenues increased for the Tchibo subgroup by 4%, pushing foreign business as a proportion of total revenues to 23%. This means that the companies' international business branch becomes, to a greater extent, important for Tchibo.

In the final months of 2008 and at the beginning of 2009, worldwide economic activity declined considerably as a result of the financial crisis. Since the third quarter of 2009, the economy in nearly all countries has recorded a slight growth again. As a result of the financial crisis, however, the economy is slow to develop due to adjustment processes in the industrialized countries. The retail sector reported a revenue decline in 2009. Still the effects of the financial crisis on the retail sector were small when compared with other branches of the industry.

#### 6.3 Business Strengths and Weaknesses

#### 6.4 Competitive Advantages and Success Factors

#### Competitive advantages

- Early adopter of Internet and strong in e-commerce: Tchibo has an online store. Customers can reach every product with special offers in its food or nonfood products. Tchibo's competitors are not strong enough to reach the level of Tchibo's success in e-commerce. Almost none of them has online stores except its indirect competitors like hypermarkets and department stores.
- Unique three-in-one-store model: The nonfood, coffee, and coffee-bar divisions comprise an up-to-date and harmonious three-in-one-store concept. Tchibo's unique store model does not exist in its competitors. For example, Starbucks has coffee and coffee-bar divisions, but it does not have nonfood products except coffee machines. These nonfood products in Tchibo can be fashionable clothes that are attractive for some customers who are willing to pay for clothes during shopping. This is another competitive advantage of Tchibo.
- Every week a new experience marketing concept: Tchibo's every week a new experience marketing concept serves a very different consumption experience to its customers. Starbucks, other specialty coffee retailers, or any competitor belonging

to the food industry do not focus on this marketing concept. Every week new designs and brand-new nonfood products are ready to be sold on the shelves. Tchibo's special coffees have a lead role each week according to the concept. This marketing concept is very attractive to the customers. This is why it is a major competitive advantage of Tchibo.

#### Success factors

- Great know-how in the coffee and consumer goods business
- Effective advertising
- Price competitiveness
- · Customer loyalty
- Consistency

#### 6.5 Scenarios and Opportunities

#### 6.5.1 Positive Scenarios for Industry

- If there is a possible quota or trade barrier for Turkey, this will decrease production and sales.
- If there is an increase in disposable income of households, sales will increase as well.
- In the long run, due to the increase in the young population, the demand for coffee and nonfood products will increase.
- Growing franchise industry in Turkey.
- Potential growth of Internet technologies and e-commerce will increase the online sales.

- Household income and demand for consumer goods rise.
- Future coffee consumption may increase.

#### 6.6 Main Goals and Main Strategies

#### 6.6.1 Main Goals

#### Financial and marketing goals

- Make more investment on advertising

- Open new stores with lower store-opening costs

## Operational goals

- Increasing the share of sustainable coffee. Make new arrangements with other countries that have coffee beans as raw material for new specialized coffee types that are not currently selling in the store.
- Invest more in R&D to develop new products for the *every* week a new experience concept.
- Maintain the social benefits package even in tough economic times.

# 6.6.2 Main Strategies

Tchibo has a great expertise in the coffee and consumer goods market. Over the years, Tchibo established good business relations with its partners and suppliers; therefore, Tchibo can offer high-quality products at a good price. Besides, there are no direct competitors. A niche could be created in new markets.

Since Tchibo only has little experience in globalization, entry strategy would be via joint venture. Tchibo has great opportunities to offer and a joint venture with local business partners that have experience and great knowledge in local markets can be very beneficial for both business partners.

In existing markets, Tchibo shops are owned by Tchibo or franchisees. The unique three-in-one-store model is excellently marketable as a franchise concept. Besides, Turkish franchise market has a growth potential that gives Tchibo the opportunity with less risk.

Additionally, in order to manage costs and ensure compliance with the company's rigorous standards of freshness, quality, and consistency, the company should control its coffee sourcing, roasting, and retail sales.

# LIFE...TO Go!\*

Life...to go! is an online-based delivery service of what will initially be groceries. It is a service company that allows customers to visit its website, order and purchase their groceries, and then have them directly delivered to their door or to their address of choice. The inventory of grocery products will be provided by the company's partners, which are two supermarkets with a significant market share in the Dutch market and who are direct competitors of the largest supermarket chain in the Netherlands, Albert Heijn (AH).

This partnership allows *Life...to go!* to benefit from an established customer base and well-known brand names and high-quality and service evaluation while providing the partnering supermarkets with a way of competing with AH in the online-delivery service industry without incurring too many additional costs and/or risks (compared to if they started such a venture on their own) and by hopefully capturing a part of that market as well.

The company's target group is busy, on-the-go consumers with little time available in the day to get all their necessary activities done. For many people, this means continually pushing certain activities to the background until the very last minute or until it is too late and that is where *Life...to go!* comes in and offers an easy solution to one of life's everyday chores such as grocery shopping.

Similarly, the consumer segment of the elderly or physically and even perhaps mentally disabled is also a target group for the company. The service does not have to necessarily be provided directly to this segment itself but perhaps to their caregivers as this group of customers also has a lot on their plate. Caregivers can be anyone from family to friends to health-care providers who are paid to take care of those

a bit more challenged than others. This service can also help them in their own lives by lightening the chore load after they have punched out from work, but it can also help them during working hours while assisting those they are responsible of taking care of, which might include helping them with grocery shopping.

#### Mission

Our aim is to provide a one-of-a-kind, efficient, and time-saving online-based delivery service for our customers who have other more time-consuming priorities. Our service has a broad reach that saves our customers time and allows them the space and freedom to conduct their other, more pressing daily activities.

In short, our mission is to provide an adequate, efficient, and time-saving service for all our customers with quality and a personal touch.

#### 7.1 Environmental Analysis

#### 7.1.1 Macroeconomic Analysis

7.1.1.1 Demographic Everyone goes to the supermarket at some point. The Netherlands has approximately 17 million (16,669,112 in 2011) inhabitants, who go to the supermarket an average of two to three times per week in order to meet their most basic needs. A very small amount of those inhabitants utilize the online delivery service of two main providers (discussed in detail in the competitive analysis) of online delivery of groceries.

Dutch residents go to the supermarket an average of two to three times per week, which is quite often. Therefore, it can be assumed that the people who use an online grocery delivery service are usually quite busy during the day (and in their daily lives in general) and thus have no real spare time to go grocery shopping.

7.1.1.2 Judicial—Political A quarter of consumers have a choice from one or more supermarkets when they need to go grocery shopping. This is because municipalities have no legal means to regulate the establishment of supermarkets, which is a testament to the powerful position of large supermarket chains.

SOMO (Stichting Onderzoek Multinationale Ondernemingen) did earlier research into the increasing power of supermarkets. With regard to the fact that they are increasing, consumers embrace them as suppliers of a wide choice of low prices. This development allows for a dominant position of supermarket chains, at the expense of small grocers.

The current legislation protects supermarkets relative to the aggressive behavior of food producers, which was needed in the past. However, the roles have exchanged. The supermarkets are strong players now, and an outdated legislation places them strategically on the map. Still, supermarkets have generally little to say about legislation and AH, in particular, would like to see a change in this. For example, AH wants a law passed for sustainable products in which the government will force a breakthrough in the market for and of organic and fair trade products.

On another note and with regard to more standard and general legislation, there are generally three laws of food safety: the Consumer Goods Act, the Consumer Goods Act Hygiene Scheme of Foodstuffs, and the Consumer Goods Act Preparation and Handling Scheme of Food; and to ensure food safety, there are also certain procedures such as HACCP and quality standards.

Finally, all supermarkets also have a law on shop opening times; that is, how long supermarkets may stay open and also being open on Sundays, because in the Netherlands, on the last Sunday of the month supermarkets can only be open for a certain amount of time. In addition, there is, of course, the alcohol ban for young people under 16 years of age and identification must also be shown if asked by an employee of the supermarket.

7.1.1.3 Economic In order to take a closer look at the external factors influencing the industry and subsequently the company from an economic standpoint, this section will examine the purchasing power of consumers, which reveals that in 2009 Dutch people had on average 1.4% more to spend than in 2008; however, entrepreneurs and independent (self-employed) people still saw their purchasing power being reduced through sudden sales declines. This is evident from the figures that the Central Bureau of Statistics (in Dutch: Central Bureau voor Statistiek [CBS]) has announced. The slight growth in purchasing

power was particularly due to the large number of Dutch people who were employed and that kept their jobs.

The disposable income of that group rose by 3.1%. It was the Dutch independent entrepreneurs who were hard hit in 2009. They saw their turnover plunging and lost on average more than 4% of their purchasing power; that effect was also reflected in higher-income households that earned more than €160,000 gross and who were relatively independent entrepreneurs. They were the only income group that, in 2009, went backward. According to a CBS economist, Muligen, it was very well possible that in 2010 the independent entrepreneurs would be the first to benefit from the recovery that occurred and continues to occur.

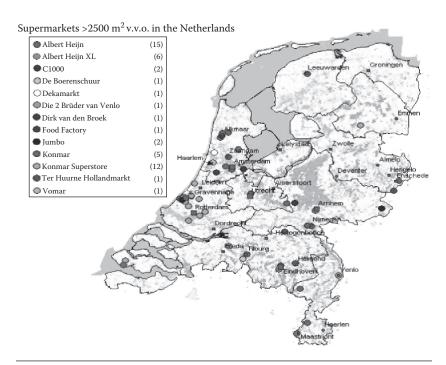
At that time, it was predicted that in 2010 and 2011 the purchasing power of the average Dutchman would fall (average wages would decrease) as a result of a delayed effect from the most serious crisis since the 1930s. A similar effect occurred in the period after 2003 when the purchasing power fell, and then again in 2005 when it decreased as a result of a year with weak economic growth.

However, with regard to 2011, it can be said that the purchasing power had risen as consumers' purchase behavior was becoming more expensive due to the soaring prices of commodities (food items are quickly becoming expensive). This is an approximate 30% rise based on research firm GfK—short for Society for Consumer Research. In June 2011, the prices increased by another 3%, which was higher than the previous year. As a result, consumers are now massively purchasing differently according to Joop Holla (GfK), they go to cheaper supermarkets, they choose less well-known brands (A-brands), or they choose substitute products.

7.1.1.4 Sociocultural For sociocultural factors in the supermarket industry, the focus will mainly be on the current lifestyles of customers in the current economic situation and what is *in* at the moment. A sustainable diet (healthy lifestyle) is the newest trend for customers to engage in, and they expect to see supporting products in the supermarkets. Consumers are increasingly buying organic (products), and especially for fresh products (such as produce), consumers like to buy the biological alternative.

Also, the typical traditional supermarket is slowly disappearing. The future belongs to the hypermarket and the small city grocers, where assortment is strongly extended. It is also predicted that the traditional distinction will fade between discounters (such as Aldi, Lidl, and Dirk van den Broek) with low prices and a limited supply, on the one hand, and with *luxury* supermarkets such as AH and Super de Boer with higher prices, a wide assortment and lots of fresh products, on the other hand. An overview of all mega supermarkets (i.e., supermarkets larger than 2500 m²) in the Netherlands is shown in Figure 7.1.

Together with the CBL annual report, the researched consumer trends were also announced; this was a large national research focused on what consumers currently think about supermarkets. The research revealed that although 97% of the Dutch population believes that the supermarkets respond to their wishes, they still have additional needs that can be seen next. However, consumers gave the supermarkets an average report rate of 7.7.

The CBL needs the following top five looks:

- 1. Quick cashiers (84%)
- 2. ATMs (72%)
- 3. Pinning extra money at checkout (cashiers) (71%)

The consumer wants supermarkets to extend their range even further. Products and services that the consumer also likes/wants to avail in the supermarket are

- Medicines without a prescription (71%)
- Map and ticket sales (69%)
- Liquor (68%)
- Photo service (64%)
- Office supplies (64%)

### There are also annoyances:

- Long wait at checkout (28%)
- Discontinued items (23%)
- Refill during opening hours (22%)
- Sold-out items (21%)
- Sold-out listings (19%)

7.1.1.5 Technological Technology is constantly changing and, for the most part, improving for the better. However, technological advances and improvements are not intensely relevant for this firm and industry. The extent of the technology used in such a firm is limited to programs, processes, and procedures that are designed to facilitate the online delivery process.

The facilitation of the online delivery firm could occur through advances and improvements in programs used. Programs include those used for taking, processing, and tracking customers' online orders and grocery lists. Improvements in the technology behind those programs could help to reduce the time needed to process a customer's order, thus reducing the time between order and delivery, making delivery times shorter. Newer and more advanced technologies could also help reduce the amount of errors made while processing orders.

Furthermore, a technological look at the processes used within the supermarket sector itself will reveal that the most important programs used are, among other things, programs to keep and track inventory and to maintain a smooth running check-out/purchase and payment system.

The latter technological programs, and thus its advances, are not necessarily directly relevant to this firm. It is, however, indirectly relevant to the firm through its partnerships with various supermarkets. Thus, if, for example, technological advances help to improve a supermarkets, efficiency in inventory turnover and stock-keeping procedures, then these advances and improvements could also be indirectly passed on to the online firm and perhaps even improve its operations as well.

### 7.1.2 Competition Analysis

Michael Porter's five forces model describes the crucial forces that influence a firm as being *potential entrants*, *buyers*, *substitutes*, *and suppliers*. This section does not discuss the role of substitutes as they are not crucial to this particular industry.

7.1.2.1 Rivalry Life...to go!'s competitors (mainly AH) are crucial to the company due to the fact that they are much more experienced with the industry and the market than Life...to go! is. Their experience is mainly based on the core business of a physical supermarket itself and its activities, but that experience carries a lot of weight over into the concept of an online delivery service for groceries. Their leadership positioning along with their almost oligopolistic position within the market allows them to have a fairly significant and incredibly crucial amount to say when it comes to new entrants within the market. This makes their bargaining power extremely high and feasible.

7.1.2.2 Suppliers Life...to go!'s suppliers and partners can almost be seen as one in the same. This is due to the fact that the online delivery service will be working together with various supermarkets that currently do not offer such a service themselves. As such, Life...to go! will in effect be drawing upon the inventories of these supermarkets and using these as the actual physical goods that customers are purchasing online in order for Life...to go! to fulfill its service,

making their relationship not only a partnership but also, in broad terms, a supplier–retailer relationship. Due to the importance of these relationships and the fact that they are the backbone of *Life...* to go! makes the firm's partners/suppliers powerful stakeholders of the company. This makes their bargaining power extremely high, almost to the point of crippling.

7.1.2.3 Customers Life...to go! is targeting the entire population (i.e., anyone who, at one point or the other, goes to a supermarket to buy groceries) with a special interest in persons who lead extremely busy lives and cannot find the time in the day to go grocery shopping. Given the nature of Life...to go!, customers are crucial to the company as with any firm. If Life...to go! fails to sell its new concept and attract customers, the company will be doomed. The customers in this company are the foundation of the firm and without them and their support, there would be no service to deliver. This makes their bargaining power extremely high, if not necessary for the survival, transparency, and constant review of the firm.

7.1.2.4 New Arrivals The industry on a whole, including the large and established players within the market, may not face such defined challenges; however, these are potential and very real challenges that any firm in this industry, whether established and experienced or not, may face. The degree to which a firm may experience such challenges may differ but the core of each challenge remains the same for players within the market, regardless of its size and status.

The only significant difference is that of the supplier/partnership relationship. The main players within the industry do not have such relationships as they serve as their own *partner* in a manner of speaking. The supermarkets serve as retailers to the companies who produce the various products, but in regard to the online venture, they already have everything they need in-house and do not need to look elsewhere. This counts for the entire industry on a whole.

# 7.1.3 Industry Life Cycle

The industry in which this firm is part of has been around for quite some time; however, it is starting to gain true momentum and recognition only now, thanks, in part, to the invention and wide-spread use of the Internet.

Nevertheless, out of the four stages of the industry life cycle, which are the introduction, growth, maturity, and declining stage, this particular firm (as well as the industry itself) is in the *growth* stage of its life within the industry.

Established firms are now mainly focusing on their brand/image as a differentiation tool in order to attract new customers and to keep existing ones, and prices are starting to decline. The level of competition and the amount of new entrants into the market/industry have also begun to steadily rise causing even more difficulties.

Life...to go! can therefore also be seen as a struggling new entrant of sorts. Although the industry in the Netherlands does not consist of many players, the players that are actually present carry a significant amount of weight and they are well known and already established, making this new endeavor of Life...to go! a very risky and ambitious one. The firm will be going head-to-head with a few big-named players in what can be seen as a volatile and yet still largely untapped market and industry.

# 7.2 Internal Analysis

### 7.3 Competitive Advantages and Success Factors

There are approximately 4300 supermarkets in the Netherlands. Only a very small amount of these supermarkets provide the online service that will directly compete with *Life...to go!* 

Life...to go!'s main competitors are AH, Boni, and DekaMarkt because they also offer the online grocery delivery service. However, DekaMarkt cannot be considered as a direct competitor of Life...to go! because DekaMarkt's online service only provides online preorder of the customer's groceries, after which the customer is still required to physically go to the supermarket to collect their preordered groceries. The largest competitor is AH, which is a part of the Ahold group. AH reportedly had 824 supermarkets in the Netherlands in 2008 with a visitor's rate (usage rate) of 69%.

AH has a cost leadership position in the Dutch market, and as illustrated by the matrix given earlier, this is the best possible strategy to have as it provides both competitive advantage and scope by having low costs while catering to a broad market. Boni and DekaMarkt can be categorized as having a broad differentiation focus because even though their costs are not extremely high, they are still higher than those of AH, and because they also cater to a broad market.

Furthermore, with regard to AH's and Boni's pricing, Boni delivers orders for €5.95 with a minimum purchase of €50. Interesting to note with Boni though is that they operate in cities in the northwestern of

Holland such as Flevopolder, Zwolle, Apeldoorn, Almere, Lelystad, and Zeewolde, whereas *Life...to go!'s* operations will initially be based in the south of Holland.

With regard to AH's pricing, AH delivers orders starting from €3.95 with a minimum purchase of €70 and with no transportation costs included with a purchase of €100 or more.

The Dutch supermarket sector can be divided into three subsectors consisting of the primary supermarket sector, the secondary supermarket sector, and the tertiary supermarket sector. These sectors are defined by the customers' perceived quality level combined with the (per week) patronage rate.

The primary sector can be seen as the customers' first choice when shopping for daily groceries. AH is one of the leaders in this sector, and it had a patronage rate of 36.6% per week in 2011.

The secondary sector can be seen as a *substitute* to the primary sector, as customers usually patronize the supermarkets in this sector in certain situations such as due to proximity and convenience of that supermarket when they are pressed for time. In 2011, Boni joined this sector with a patronage percentage of 0.8% per week. This is an improvement for Boni since in 2010 they were considered a part of the tertiary sector with a substantially lower patronage percentage per week. The tertiary sector can be considered a customer's *last resort* when shopping for groceries and will usually be patronized in the absence of or relatively far distance from/or lack of time to go to primary and/or secondary supermarkets.

# 7.4 Scenarios and Opportunities

7.4.1 Positive and Negative Scenarios for Industry

It can be predicted that in 3-5 years' time,

- Companies (especially new entrants) within this industry may be experiencing difficulties as their individual stakeholders may not be in tune with each other and thus bringing the company down with them.
- Large, monopolistic players may be able to survive challenges that such an industry is inherent to but the smaller, perhaps newer entrants may find it much more difficult to stay afloat.

• The industry will definitely expand and grow larger due to the fact that people's lives are becoming busier by the day and consumers try to fit as many things into a day as possible at the expense of the smaller chores that they do not count as being of high priority. This will increase the need for a variety of online services that will also attract many other new entrants seeking new opportunities and profits in this industry.

#### 7.4.2 Business Opportunities and Threats

7.4.2.1 Opportunities The information provided throughout this report gives way to the following opportunities for *Life...to go!* 

- The company will have a strong entry into the market due to its strategy of creating partnerships with already established supermarkets and turning that into a win-win situation for all parties involved.
- The possibility of retaining a significant market share is large due to the fact that the market is currently inhabited by very few firms, leaving space for new entrants with fresh ideas.
- Entering the market may be made easier due to its partnerships, that is, the firm will immediately have access to a variety of product mix/offering and expansion potential, and the firm will also initially be *riding on the coattails* of its partners, utilizing their well-known images as it gradually builds its own.
- Moreover, the laws regarding opening times mentioned in the external analysis under legislation also provide an opportunity for *Life...to go!* as being an online-based service to be open, in effect, 24 h a day, 7 days a week, and 365 days a year. Of course, delivery will not be done at all hours of the day and night, but this allows consumers to preorder their groceries and to have them delivered the following day, for example. This, once again, proves the effectiveness, efficiency, and value that *Life...to go!'s* customers stand to gain.
- Finally, the points mentioned earlier, in the section of the external analysis regarding the sociocultural aspect, show

gaps in what supermarkets currently offer customers and what customers perceive to still be missing in this service, which translates into what they would like to see throughout the industry as a whole.

These gaps are opportunities for *Life...to go!*, opportunities with great chances of becoming a reality because the company can use such information in its expansion plans by offering some of the products and items that consumers cannot currently get in their preferred supermarkets. Not only is the company already providing convenience, ease of purchase, and efficiency by being an online-based service, but *Life...to go!* can capitalize on this and the supermarkets' flaws by becoming an entirely invaluable one stop shop for consumers.

7.4.2.2 Threats The information provided throughout this report gives way to the following threats of Life...to go!:

- The firm is highly inexperienced and unknown.
- Retaining partnerships is an assumption, and there is no guarantee that supermarkets will be willing to partner with Life...to go!:
- Barriers to entry will be made significantly more difficult due to semimonopolistic players in the industry.
- The firm will initially be *riding on the coattails* of its partners, utilizing their well-known images as it gradually builds its own; this leaves the firm vulnerable to threats mainly related to its partners. For example, if one of the partners falls on hard times or goes through a very public controversy, this will be reflected on *Life...to go!* as well even though the two may have nothing to do with each other.
- Retaining significant capital may prove difficult due to the
  fact that Life...to go! is highly inexperienced and green as
  they say. And if the potential partners decide/agree to invest
  within the company, this may signify new and different challenges to the firm such as potentially losing control of its own
  operations and possibly even losing its identity.
- The firm has minimal to no leveraging position.

# 7.5 Strategic Objectives, Main Goals, and Main Strategies

7.5.1 Strategic Objective and Main Goals

Life...to go!'s objectives will be strategic in nature.

In the coming years, the fight for supermarket customers will not be situated in the shop but on the Internet, and AH has a (huge) lead at the moment. At the moment, AH is currently the only supermarket with a relevant online presence. It can be assumed that from 2016 they will have a market share of more than 50%. The online supermarket in 2016 will be good for a turnover of approximately €700 million, which will ensure that there will be a revolution in this sector. And if online becomes popular and large, then AH will have most of the industry's growth and will be able to hijack turnover away from its competitors.

Life...to go! wants to enter the market when the online supermarket sector is still relatively small (1% market share) and position itself next to the number one supermarket in the Netherlands (within 3–5 years) at the moment, AH. Life...to go! believes it can differentiate itself from AH by taking other supermarkets under their wings, and basically partnering with these supermarkets. In this way, Life...to go! will become the next best online supermarket (supplier) with a range of multiple supermarkets for consumers to choose from, thereby giving consumers more options of online grocery shopping to choose from (larger variety).

Finally, since it has been predicted that the online supermarket sector will increase in the coming years, Life...to go! will have a better chance of entering the market now while the competition level is still very low, and the company can then grow (its market share) and expand over the coming years and position itself as a significant competitor alongside AH. Life...to go! wants to partner with some of the largest supermarkets and competitors next to AH, such as Jumbo (second largest supermarket in the Netherlands), Super de Boer, Bas van der Heijden, and Coop. Hereby the supermarkets will not have to open their own individual businesses online and all the resources and financial costs that come along with it. Life...to go! will provide them the same opportunities, with fewer risks and the company basically does all the work for them. This is a win-win situation for all parties

involved, which will make *Life...to go!* the only online business with various supermarkets to choose from in the Netherlands.

#### 7.5.2 Main Strategies

The most appropriate strategies for *Life...to go!* are *market penetration* and *product development*.

Market penetration strategy was chosen because the company will initially have to be aggressive within the market as both the market and the product (in this case, the service) is already known/existent. And as *Life...to go!* cannot modify the product and because the market and industry is a highly competitive one, it may be challenging at first. Therefore, this strategy calls for much determination and perseverance, and with hard work, the goals and objectives will be met.

This strategy was chosen as a precautionary method with the future in mind. After establishing its presence and making a name for itself, Life...to go! will need to seek new ways of surviving, staying fresh, and keeping its customers as the penetration strategy might no longer be viable, hence the need for a product development strategy or, in this case, more like a service development strategy. The word service is used because the company has no control over the development of the tangible products (i.e., groceries) handled and delivered by them. This strategy is necessary because it will ensure future survival and profitability, not to mention a competitive edge over its competitors. It will be crucial for the company to develop new or modified ways of delivering its service while still granting a high customer satisfaction level. Because of these reasons, it is wise for the company to have such a strategy in mind now and to begin working on the essentials of such a strategy early in the game before it is too late in order to be prepared for whatever may come.

- Comply with all applicable laws and regulations of the countries in which we operate.
- Insist on realizing production and after-sale services by considering health, safety, and environment.
- Contribute local production and work with others to enhance the benefits to local communities, and to mitigate any negative impacts from our activities.

### 8.1 Environmental Analysis

#### 8.1.1 Macroeconomic Analysis

8.1.1.1 Demographic Indicators show that the population is increasing. This situation will affect businesses positively in terms of work force and customers who search for healthy nutrition.

*Education level*: For businesses that target customers who search for high-quality taste and healthy nutrition, an increase in education level will positively affect them.

8.1.1.2 Judicial–Political Incentives: The olive oil sector and exporting are supported by the government.

Green laws: Today, green production and products have important roles in different industries.

*Political stability*: Recent developments in Turkey show that political stability has a significant role for businesses. Therefore, businesses will be negatively affected from the current political climate.

8.1.1.3 Economic Distribution of income: Inequality in distribution of income will continue, which will limit targeted customers.

Foreign exchange policy: The general trend of the government is to support exporting and foreign investment.

Degree of international trade: Due to globalization, restrictions, trade barriers, and tariffs will be more flexible, which will have a direct impact on businesses.

8.1.1.4 Sociocultural Trends show that a healthier lifestyle has become an important issue.

8.1.1.5 Natural Environment Indicators show that due to climate changes, water shortages will occur, which will have a negative impact on our industry. Therefore, there is a need to develop a new irrigation system for olive trees.

8.1.1.6 Technological In the light of organic production perspective, there is a need to systematize R&D activities for improving production quality and preventing natural production volatility of olive trees.

#### 8.1.2 Competition Analysis

The global olive oil market is one of the fastest growing segments of the global food industry, showing significant growth year after year. Olive oil is the main component of the Mediterranean diet, the health properties of which makes olive oil a food product with a promising future.

The global olive oil market grew by 3% between 2008 and 2012, but this growth rate varied widely across different markets. Traditional consumer countries in the North Mediterranean, that is, Italy, Spain, and Greece, have the highest per capita consumption (more than 12 kg per person) but are characterized as a very mature and stagnating market. In contrast, developed markets offer significant potential in terms of both value (at present, they account for 41% of the global market) and growth, with levels projected to continue at around 4% for at least the next 5 years.

Emerging markets hold the greatest potential for the olive oil industry, posting an impressive 13% growth rate over the last 5 years. Brazil and China are the two most important countries in terms of

volume and producers. China imported 45,000 tons of olive oil in 2012 and became a crucial market for producers. Several major state-owned enterprises (SOE) have been increasing their imports of bulk olive oil from southern Europe.

Private label (PL) products and A-brands represent the primary growth opportunities in developed countries. In the United Kingdom, the most developed food retailer market, the PL share in olive oil accounts for almost 5%, while it accounts for 25% in the United States and 20% in the most fragmented Italian market. The latter two markets and several other northern European markets provide other interesting growth opportunities.

There are factors that will restrict the industry's ability to realize its ambitions in emerging markets. First, there is a need for all players to strengthen their strategic sourcing options. Second, a generic marketing campaign is required in emerging markets to educate consumers about the benefits and versatility of olive oil.

Spain is the largest producer and exporter of olive oil in the world followed by Italy, while the United States is the third largest consumer of olive oil after Spain and Italy. The consumption pattern of olive oil in the BRIC countries has shown tremendous growth. It is expected that in the near future India and China will be on the list of largest consumers of olive oil as people have started recognizing the health benefits of olive oil and have accepted it as cooking oil.

As the production of olive oil is limited to some specific geography, pricing of olive oil sees major fluctuations when production or cultivation gets affected.

Turkey's olive oil exports have dramatically increased to over 45,000 tons, with a 446% rise in the last 5 months compared to the same period a year earlier. The rise is due to a considerable fall in the harvest of Spain, the world's largest oil producer, according to a sector report.

Turkey's olive oil exports, which had been halted considerably since the 2005–2006 season, started to recover last year. While exports increased to 20,000 tons in the 2011–2012 seasons, from 12,000 tons in the previous period, income from exports reached \$65 million, with a 33% increase.

The new season showed more than 400% increases in both the amount of exports and the value. As the exports reached 45,524 tons with a 446% increase between November 2012 and March 2013, the export value reached \$143 million with a 406% increase. The exports in March soared by 626% on a year-on-year basis.




Figure 8.1 Competitive forces.

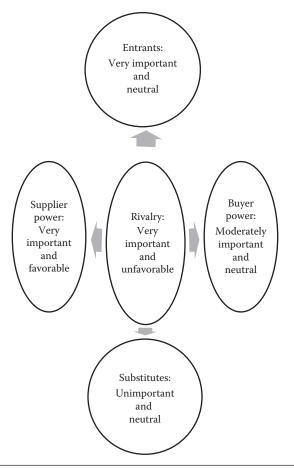


Figure 8.2 Competitive forces status.

The report revealed that a 60% loss in Spain's olive oil production because of lack of rain had boosted Turkey's exports. The 95,000 tons of olive oil production hike in Italy and Greece could not fill the gap in the market, and the European Union's removal of the customs duty on Turkey's olive oil exports also helped Turkey. Despite the recent fall, Spain still remains the largest olive oil producer in the world, followed by Italy, Greece, Tunisia, and Turkey. Figures 8.1 and 8.2 show the competitive forces status.

#### 8.2 Internal Analysis

Table 8.1 shows the strengths and weaknesses of the firm based on functional approach.

approximately 5% market share in world olive oil production. The statistics show that the demand for olive oil in emerging markets has grown at a rate of over 13% since 2007, and such double-digit growth is expected to continue at least for the next 5 years. Accordingly, by considering the increasing trend of olive oil demand, Turkey has the potential to increase its market share as well.

# Negative scenarios

• Rich soil shortages may cause negative impacts on the additional supply of olive trees and quality of products. In addition, climate changes and water shortages may negatively affect production.




Figure 8.3 Business opportunities.

#### 9.1 Environmental Analysis

#### 9.1.1 Macroeconomic Analysis

9.1.1.1 Demographic 15–64-year-old people in Turkey (who are at working ages) constitute 67.2% of the total population, which is in our target segment. Furthermore, in Turkey, there are 24,631,831 students who take notes every day. Table 9.1 shows the education distribution in Turkey.

Employment: Tables 9.2 and 9.3 show labor force statuses in Turkey. Left-handed group: In 1998, a study suggested that approximately 7%–10% of the adult population was left-handed, and that left-handedness is more common in males than females. Among other difficulties, writing is a very important problem for that group of people and this difficulty forces them to write by a very inconvenient writing style.

9.1.1.2 Judicial–Political Writing for the World Bank's Governance Matters in 2009, authors Kaufmann, Kraay, and Mastruzzi assign Turkey a score of -0.73 for the factor Political Stability and Absence of Violence/Terrorism in the report's governance indicators for 1996–2008. These indicators are normally distributed around a mean of zero. Higher scores signify less violence and greater political stability in a society.

The U.S. Department of State's 2010 background note on Turkey notes that, following a military coup in 1980, Turkey drafted a constitution (enacted in 1982) that established a democratic, secular, parliamentary form of government. Vagueness in the law regarding presidential power means that a president's ultimate influence is dependent upon personality and persuasiveness. Executive power is shared between the president and the prime minister, the latter of whom serves as the leader of the council of ministers. Beginning in 2007, the presidential term was reduced by constitutional amendment

from 7 to 5 years, with a two-term maximum. The president is elected by direct popular vote.

Parliament members are elected according to *party-list proportional* representation, which is based on minimum national and district voting percentages. Passage of a parliamentary vote on which a popular referendum has been held requires a 60% vote (330 of the 550 members); otherwise, a two-thirds majority is required.

The judiciary is nominally independent, but the U.S. Department of Commerce's 2010 country commercial guide notes that there are perceptions that the judicial system is subject to political interference. The DoS adds that Turkey has a Constitutional Court, a Supreme Court of Appeals, a Council of State, a Court of Accounts, and a Military Court of Appeals. Supervision of the judiciary is carried out by the presidentially appointed High Council of Judges.

To sum up, the stable political environment in Turkey will be advantageous in establishing a new business in Turkey.

9.1.1.3 Economic Turkey's economy is increasingly driven by its industry and service sectors, although its traditional agriculture sector still accounts for about 30% of employment. An aggressive privatization program has reduced state involvement in basic industry, banking, transport, and communication, and an emerging cadre of middle-class entrepreneurs is adding dynamism to the economy.

Turkey's traditional textiles and clothing sectors still account for onethird of industrial employment, despite the stiff competition in international markets that resulted from the end of the global quota system.

Other sectors, notably the automotive, construction, and electronics industries, are rising in importance and have surpassed textiles within Turkey's export mix.

Oil began to flow through the Baku-Tbilisi-Ceyhan pipeline in May 2006, marking a major milestone that will bring up to one million barrels per day from the Caspian to the market. Several gas pipelines also are being planned to help move Central Asian gas to Europe via Turkey, which will help address Turkey's dependence on energy imports over the long term.

After Turkey experienced a severe financial crisis in 2001, Ankara adopted financial and fiscal reforms as part of an IMF program. The reforms strengthened the country's economic fundamentals and

ushered in an era of strong growth, averaging more than 6% annually until 2008, when global economic conditions and tighter fiscal policy caused GDP to contract in 2009; reduced inflation to 6.3%, a 34-year low; and cut the public sector debt-to-GPD ratio below 50%. Turkey's well-regulated financial markets and banking system weathered the global financial crisis and GDP rebounded strongly to 7.3% in 2010, as exports returned to normal levels following the recession. The economy, however, continues to be burdened by a high current account deficit and remains dependent on often volatile, short-term investment to finance its trade deficit. The stock value of FDI stood at \$174 billion during the end of 2010, but inflows have slowed, in the light of continuing economic turmoil in Europe, the source of Turkey's FDI.

Further economic and judicial reforms and prospective EU membership are expected to boost Turkey's attractiveness to foreign investors. However, Turkey's relatively high current account deficit, uncertainty related to policymaking, and fiscal imbalances leave the economy vulnerable to destabilizing shifts in investor confidence.

#### 9.1.2 Competition Analysis

9.1.2.1 Rivalry Pilot: Despite high customer awareness, Pilot has been losing blood since 2000 against Speedy. The distributor of Pilot is a strong company and offers a variety of brands to the market. They mostly focused their attention on liquid ink roller ball category, and they do not have a similar or equivalent product yet in the Turkish market.

However, they introduced an equivalent product, Acroball, in other markets. Pilot positions this pen as a new generation of ink for out-of-the-ordinary writing flow and smoothness.

*Pentel*: Pentel is a Japanese competitor that offers very important products to the market. BK77 is very popular in the market and gained a very good position. Despite its simple design, its smoothness is the most distinctive feature of the product.

Another distinctive product of Pentel is Hyper G, which was introduced in September 2008. As a gel ink roller ball pen, Hyper G offers only four colors and only a retractable version is available. In Turkey, consumers prefer with cap versions mostly. Pentel's position statement is: Hyper G guarantees an ultra-smooth writing experience every time and boasts archival quality ink to protect important documents against fraud.

Papermate: Papermate is a rival brand in the United States, but they are not a well-known brand in Turkey. In the last year, Sanford, the owner of the Papermate and Rotring brand, acquired the Turkish distributor as a forward integration policy. They introduced Flexigrip in 2008, and their motto is *Probably the smoothness pen in the world*. Despite the design disadvantage, Flexigrip's core offerings are very similar and the first results seem above the expectation of other market players.

Schneider: Schneider is a famous German brand in Turkey, and they offer a variety of goods in Turkey. They offer Glider in 2008 to the market, and they positioned this gel ink pen as a superior smooth pen. Their motto *High speed glider from Schneider* emphasized that they are a competitor of Speedy in the sense of smooth feature.

Zebra: Zebra is another Japanese pen manufacturer. They introduced emulsion ink in 2011. Their strategy is very similar to the other brands; they also would like to give a name to hybrid ink technology. They also claimed that they invented this ink in order to get the advantages of oil-based ink and water-based ink.

As can be seen in Table 9.4, most of the well-known brands have some activities to rejuvenate their products. They introduce new phenomenon to the industry. But these brands are not able to create a distinctive difference in the market because of the following:

- Low involvement of the customers create a distinctive problem for these brands.
- Not having a distinctive image.
- Their wide range of products harms the awareness of the consumers.
- They target broad segment and it prevents them to allocate their resources effectively.

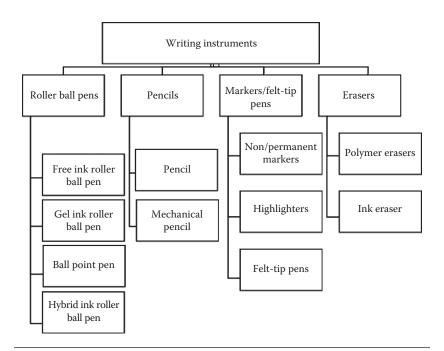


Figure 9.1 Writing instruments industry product category.

- 9.1.2.2 Customers The writing instruments industry offers lots of new products that can be categorized (shown in Figure 9.1) as follows:
  - Free ink roller ball pen: The ink is in liquid phase and a rolling ball transmits the ink onto the paper fibers. The production of free ink roller ball pens requires high tech because it is more likely to leak in case of any possible production defect.

- *Gel ink roller ball pen*: The ink is in gel phase. By the help of the rolling ball, the viscosity of gelled ink turns to liquid, so that the ball can transmit the ink onto the paper.
- *Ball point pen*: It is the oldest form of roller ball pens. The oil-based ink requires much more pressure than other types of pens. The most common and commoditized pen types are widely used as a promotion material.
- *Pencil*: Writing instruments that consist of a thin rod of graphite and a cylindrical barrel. Nowadays, the consumption patterns shifted to mechanical pencils where the graphite lead is pushed out of the pen by a mechanical system.
- *Markers*: A marker pen, marking pen, felt-tip pen, or marker, is a pen that has its own ink source, and usually has a tip made of a porous material, such as felt or nylon. The manufacturers produce a lot of markers for different purposes, for example, window marker, whiteboard marker, highlighter, and textile marker. Despite the old technology it involves, some felt-tip pens are very popular like Point 88 of Stabilo.

The estimations show that the size of the worldwide writing instruments market is \$18 billion in 2009. The global crisis squeezed the profits of some of the biggest office products and stationery industry's brands and forced some of the major markets to get smaller, especially in Western Europe and the United States.

The developing economies of the Middle and Far East, much of Asia Pacific, Africa, and South America still keep their healthy growth rates.

Although South America and Asia Pacific regions are not protected from economic troubles, market growth has been stimulated by the rising demand for quality writing instruments and population increase.

Chinese manufacturers still market to the low/mid level of consumers, but it is certain that brightly colored promotional pens, novelty-shaped highlighters and models with flashing LEDs, or retractable paper rolls continue to gain popularity.

Despite the general perception in the global market, the quality of Chinese writing instruments is very low. However, the quality and the range of products are improving every year. Chinese manufacturers tend to focus on novel digital features, ergonomic barrel shapes, environmentally friendly designs such as large-capacity highlighters, markers with reusable ink containers, and pens featuring recycled newspaper barrels. In the recent years, they do not follow the leaders, they innovate their own products.

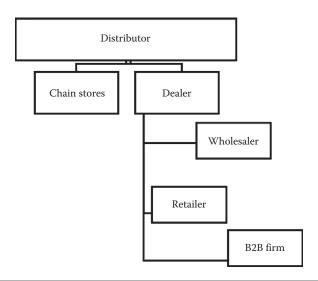
In the Turkish writing instruments market, we may see a lot of different brands, some of them are Turkish and some international.

The most distinctive problem in the market is that the sizes of the players are relatively small. The number of retail points are approximately 35,000 throughout Turkey and 10,000 of them are located in Istanbul.

It should be noted that the writing instruments sector is an exportbased sector and most of the well-known brands are international brands. Some of the international firms have subsidiary establishment in Turkey, and some of them have appointed a distributor in Turkey. However, the distribution system is very concrete for most of the distributors and almost all of them distribute their goods in the same manner.

The most vital issue that we have to take into consideration in understanding the distribution system is that most of the retailers are not professional people but small-scale retailers. The distribution system in the writing instruments industry is shown in Figure 9.2.

Compared with developed economies like the United States, the most important drawback of the Turkish market is the uneducated retailers who have an obvious lack of expertise about stationery. For example,

huge stationery retails like Staples, Office Max, or Office Depot are able to run their business in a professional way, and they have expertise about the products and also the retailing of stationery goods. In such cases, the value chain can be assessed much more easily and the costs and price fluctuations can be controlled without suffering the pipeline effect.

We can classify Turkish stationery stores as specialized retail stores, a single unit of retail that carries a specific line of goods and specialized in it. Like other specialty stores such as drug, haberdashery, and hardware stores, the stationery stores focus on stationery and related materials and services.

Another disadvantage of the Turkish stationery sector is the pipeline effect. The most critical issue in the distribution ship design is controlling the risk and finding the most economical and effective functions. Sometimes, the competitive environment and established system constrains the distributors in their selection, as in the Turkish stationery market. Sometimes, the established market conditions make it impossible to work without a middleman. Despite the current situation, the experts can easily forecast that the middleman is disappearing in the modern business world because of the ease with which companies can communicate with and inform consumers about their products.

Despite the fact that distribution channels are modern in developed countries, the Turkish stationery market consists of traditional distribution channels.

The branded writing instruments were distributed according to the chart given earlier. As mentioned earlier, approximately 35,000 companies (retail shops or B2B companies) are operating in this sector, and such a high number of sales points make the distribution system complicated.

Most of the international brands focus on the developing markets to enlarge their businesses. With the help of the young generation, Turkey is definitely one of the most prospective markets. Despite the lack of official data, the approximate size of the writing instruments sector is 200 million USD, whereas the Turkish stationery market is estimated to reach more than 1 billion euro.

The size of the market is still growing because of the young generation of Turkish population, which is around 20 million.

The chain stores are very interested in stationery products because they perceive the stationery sector as an additional revenue source, and they are trying to create a competitive advantage against the competitors.

#### 9.1.3 Industry Life Cycle

There is a debate in branding circles as to whether or not a brand can have a *life cycle* of its own, or whether its peaks and troughs are just a symptom of managing the brand elements, which are its logo, personality, positioning, etc.

In a product life cycle, the peaks and troughs can come in a quicker timeframe, making the cycle more obvious. A brand can have a rise, and then fall out of favor, to be superseded by a new and improved brand. The fact that the branding process takes many years affects the universal acceptance of the existence of a brand life cycle. Without careful management, brands can follow the general pattern of a product life cycle: moving through introduction, growth, maturity, and decline stages in a relatively rapid fashion.

For multiple products, the marketer's task is more complex as he or she needs to map the various life stages of each of the products to stagger and phase them across the product universe in order that each product life cycle is fully optimized for cash generation across the business horizon.

Product rejuvenation ideas could be generated from the perspective of enhancing or changing the product features, adding new usages for the product, enhancing the product manufacturing process, product packaging technological innovation, creative and unique channel delivery process, etc.

We have to create a difference through innovative solutions. Our aim shall be injection of new life to writing instruments.

# 9.2 Internal Analysis

As a new company, the following internal analysis is conducted:

# 9.2.1 Marketing

- Our product will fulfill the need of note taking at any time and our product will be easy to access for the consumers.
- It requires an extended product line for a niche segment, which we will be able to accomplish in a short period of time.
- We will decide the portfolio to allow the consumers to be aware of our brand and to position our brand in their mind easily.

- Unlike most of the other writing instruments brands, we will just focus on the *note taking* phenomenon, not on the whole writing instruments segment.
- The products' expansion potential is limited.
- Channels of distribution are kept by the competitors; and as a new brand, we have to fight for a place in the distribution channel.
- Due to the former proficiency, one of our top managers has a deep knowledge about the market and industry.
- We do not have product image and reputation. But we do not have negative image either.
- To create brand awareness, we shall focus on the communication of our brand; however, the sales and distribution promotions will come at the first place. So, we will postpone consumer communication activities for a while.
- Because of start-up costs, we will not be able to have a flexible pricing policy.
- Unfortunately, we do not have enough data to analyze the market.

#### 9.2.2 Production/Operations

- We will outsource the production side of our business to an international writing instruments producer. So it will help us focus on the marketing side of our business.
- Raw materials are very easy to access and the costs are at mid level.
- Because we outsource the production and our job is just stocking a few SKU, a basic control system will be enough at the initial step.
- Location of the production will be in China/Taiwan, so it may cause a time delay in the distribution of the goods.
- Because we will focus on a niche segment and be a new brand whose sales are low, we cannot use the benefits of economies of scale.
- Vertical integration is not possible for now.
- We have technological competency as a result of our state-ofthe-art ink formula.
- Research and technology investments will be at minimum in the introduction stage.
- Our patented ink technology is our key asset.

#### 9.2.3 Personnel

- We will employ four new business and administration graduates in the sales department.
- Our salary strategy will be based on performance.
- Our relations with the employees will be much more involved and the management and employees will work as a team.
- We will use incentives to motivate the performance.
- Experience of the personnel will not be enough to compete in the market.
- In order to increase our profitability and decrease costs, we are planning to have a boutique company and a wider hierarchical structure to keep us proactive.

#### 9.2.4 Organization of General Management

- Our company will follow an entrepreneurial management style. Three partners are the head of the following departments: sales, marketing, and finance.
- A wider hierarchical structure will help us to work proactively and react in a short period of time.
- Although the firm does not have a record for achieving objectives, the management team has positive records for achieving objectives.
- As a boutique company, we will have an effective control system because of our size.
- The management has enough skill to start-up and run the company.

Most of the competitors do not have professionals who have a strong background and industry experience. Having such a manager in our management team will help us to manage the entrance difficulties. Most of the competitors are manufacturers, and they allocate their resources to manage the marketing tasks and production tasks. As a new company, we believe in the power of focusing on the marketing side of the business. Outsourcing the production will make us flexible in the market.

Our entrepreneurial management style will help us to adopt the situations easily, which is not possible for other companies in the market. Furthermore, wider hierarchical structure keeps us proactive. The products' expansion potential is limited compared to other brands.

The competitors have very high brand recognition, but their product images are not clear in the eyes of the consumers. Brand loyalty is very critical factor for the products that have very low involvement of consumers. The brand loyalty of the consumers to our competitors is very high.

The competitors in the market do not prefer to have heavy advertisement campaigns, and they do not have clear marketing objectives. If we do not focus on the consumer communication campaigns, we will not lose anything. Most of the competitors import the goods from Asia, so delay will not be a big problem. Since most of the players in the writing instruments industry are nonbranded, we position ourselves as branded company.

The structure of the company is very convenient for implementing new technologies, innovative ideas, and quicker decision making because of its size and management.

- The existing competitors cannot react effectively and in time because of their hierarchical structures and large sizes. Also, they are production-oriented and establish their strategies on the benefits of economies of scale.

#### 9.4.2 Business Opportunity

The opportunity in the market is fulfilling the need for effective note taking (quick, smudge-free, dense line, reliable) by a brand that has a simple and distinctive image and targets distinctive consumers and reaches them through specialized resellers. Also, existing competitors are not convenient for distinctive consumers, as they offer a wide range of products almost for anybody in the market. Furthermore, their size and structure do not allow them to act proactively and in time.

#### 9.5 Strategic Objectives, Main Goals, and Main Strategies

#### 9.5.1 Strategic Objective

To be recognized as a reliable and quick note taking writing instruments innovator.

#### 9.5.2 Main Goals

#### Financial and marketing goals

- Communication objective is having a clear brand image by offering a product that has a distinctive feature to fulfill the need of quick note taking for a narrow target of consumers through specialized and selected resellers.
- Creating a unique and new roller ball ink category, Speedy Ink.
   Convincing customers that this is a new roller ball ink, which is completely different than other products.
- Financial objective is to reach a break-even point at the end of year one and to 30% profitability at the end of year three.

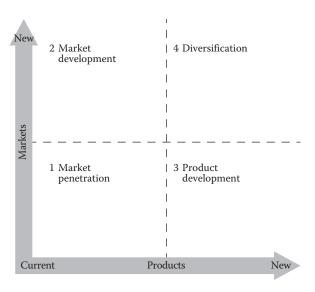
# Operational goal

According to the Porter's Generic Strategies matrix, we will also have Differentiation Focus, as shown in Figure 9.4, as we will narrow the target segment (writing instruments for quick note taking) and our competitive advantage will be based on the differentiation of our products by smooth writing, fast drying ink, and crispy lines.

Where an organization can afford neither cost leadership nor a wide scope differentiation strategy, a niche strategy could be more suitable. Here, our organization focuses its resources on a narrow and defined segment of a market.

Our business aims to differentiate itself within a small number of target markets (Turkey—students and business professionals). Within

this defined target market, there are opportunities available for us to provide products that are clearly different than competitors' (they may be targeting a broader group of customers).

The primary consumer target includes middle- to upper-level business professionals and office workers who need reliable writing instruments to feel comfortable and to be sure that the writing will not discolor from exposure to light and possess superior color brightness for a long time. The secondary target includes government officers who need a documentary writing quality to be sure that the writings or signatures endure on documents for a long time. Moreover, others include doctors, journalists, and students need to write for a long time without ceasing and need to have clear writing without smudges.

# Unified Tracking Solutions\*

#### Mission

To be the leader in the arena, Unified Tracking Solutions (UTS) provides reliable and high-tech solutions with distinguished and valuable technological know-how in tracking systems in order to satisfy the safety needs of people who need traceability. While achieving this mission, UTS always considers quality, reliability, and privacy.

#### 10.1 Environmental Analysis

#### 10.1.1 Macroeconomic Analysis

10.1.1.1 Demographic Population increase rate: Considering the average annual population growth rate in the period of 1990–2004, Turkey took place in front of India with the rate of 1.7%. The projections for the period of 2004–2020 show that Turkey's population growth rate will be 1.2%, and both Turkey and Ireland will be two countries in Europe whose population will be the fastest growing among European countries. Population will decline or remain constant in most countries in Europe. The low rates of growth trends in countries like the Netherlands, France, Sweden, and the United Kingdom are consequences of migrations.

In 2004, Turkey, with a rate of 1.52%, is the third country in Europe after Spain (1.64%) and Ireland (1.63%) whose population is rapidly growing.

Today, some of Europe's most fundamental issues include rapidly falling birth rates and the elder population. In this portrait, the

European governments are planning to reform their social security systems to make people stay longer in the labor market.

In this context, Turkey will be having significant advantages over the European Union with a well-balanced demographic structure and by increasing education and job opportunities.

Age distribution: The target age group is between 15 and 54 years. According to the regional distribution and educational status of this age group, the target audiences can be filtered again. In Turkey, more than 38 million people are between 15 and 54 years. Table 10.1 shows the age distribution in Turkey.

*Educational level*: Among 38 million of the population aged 18–54, more than 15 million has a higher education.

10.1.1.2 Judicial—Political Going through one-party power shows that stability would continue. Political crises in the Middle East region of Turkey constitute a risk of chaos. Restructuring of the Arab region toward democracy slowly turns toward capitalism. This is an opportunity for Turkish goods in the region.

10.1.1.3 Economic Income distribution: Proportional distribution of annual income by income groups, 2004 and 2005. The share of wages and salary income are more than other income types. Annual disposable income of 39.2% is wage and salary income, and 28.8% is entrepreneurs income. Table 10.2 shows the income distribution in Turkey.

Inflation: Inflation rate in June 2011 was 6.24.

*Unemployment rate*: Unemployment rate in Turkey decreased to 9.9% in June, which was about 14% in recent years.

Exchange rate policy: A policy of floating exchange rate continues, which forces the industry to manage this risk. Imports will also affect the industry.

#### 10.1.2 Competition Analysis

Companies in the industry are mostly focused on vehicle tracking systems. No company has a total solution covering the whole market (end users, corporate customers, bicycles, etc.). Only Arvento, which is the most powerful competitor in the market, offers some integrated

services, but they are also not focused on the mobile user market. There is no special product or service designed for end users in the market.

10.1.2.1 Rivalry Arvento: Arvento was established in Turkey in order to produce mobile technologies. It produces packaged software and hardware. As of today, its products are exported to 18 countries. The company is the market leader, which serves more than 9,000 customers and 120,000 vehicles. Other than the standard vehicle tracking solutions, the rest are as follows:

- Temperature control and monitoring systems
- · Ready mix concrete dispatch and fleet management system
- Public transport and urban mass transit administration tools
- Emergency operations management system
- · Staff transport vehicles monitoring and control system
- Fleet maintenance and service tracking system
- Safe ride control system
- Taxi/towing management system

Mobiliz: Mobiliz Information and Communication Technologies is an R&D company founded in 2004 to produce integrated systems that are parallel to the most recent technological developments. It produces and sells vehicle tracking systems. As of 2011, it has a staff of 45 people and more than 6000 customer portfolio. Its activities continue in Cyberpark Bilkent, Ankara Technology Development Zone.

*Elcobil*: Elcobil was founded in 2004 to produce innovative vehicle tracking systems. This company is analyzed because they supply several integrated solutions for different industries by using tracking systems. Other than the standard vehicle tracking solutions, the rest are as follows:

- · Ambulance tracking and task management
- · Vehicle allocation and task management
- GIS desktop software
- Ready-mixed concrete planning and control
- · Armored vehicle and money tracking system

- Tour reporting
- · Road risk assessment and control system
- Temperature and humidity monitoring system
- Taxi security system
- Alarm monitoring center
- · Staff transport vehicles monitoring and control system
- · Route planning and control

10.1.2.2 Suppliers Since there are many firms in the sector that offer motor vehicle tracking systems, products, and services, it reduces the sellers' power in the field. However, the companies that will offer products and services for pedestrian or pedal user group will keep the power in their hands.

10.1.2.3 Customers Since there are several companies supplying services and products in the vehicle tracking market, customers can use their power against suppliers. But for other products and services like end-user systems, customers do not have the same power because of poor competition in the market. Furthermore, even these systems bring cost efficiency for the companies that use tracking systems, which is not crucial for their core business. They can discontinue using these systems any time they want.

10.1.2.4 Substitutes Although there are no products that can be directly called as substitutes, computer manufacturers, navigation companies, or smartphone manufacturers can get position in the market at any moment. Due to the small market size, these companies probably do not enter the industry at the moment, but they must be taken into consideration seriously.

10.1.2.5 New Arrivals Since existing companies have high shares and due to the need of strong know-how about the technology, it is extremely difficult for new firms to enter the industry. Furthermore, competitors like Arvento and Mobiliz are located in the market for many years, and they have strong customer loyalties.

High investment is required to enter the market. During the development phase of integrated products and services, companies

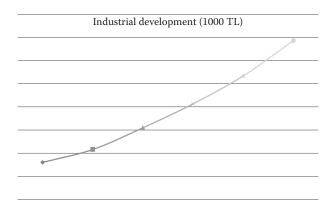


Figure 10.1 Industrial development.

must hire qualified and experienced employees. Plus, a widespread service network throughout the country should be established. In addition, costs to create integrated solutions are higher than the existing players'.

#### 10.1.3 Industry Life Cycle

Industry is at growth stage, and it is open to competition. By differentiated products with reasonable prices, companies can obtain competitive advantages. Competitors in the industry are directed toward institutional solutions, and they overlook the end-user market. Industrial development is shown in Figure 10.1.

# 10.2 Internal Analysis

We are going to provide GPS+GPRS integrated tracking system solutions for the retail market. Products will be designed in Turkey by our R&D group and will be manufactured in the People's Republic of China. This design and manufacturing function will be the responsibility of our R&D team.

In order to position our products in the retail market, existing distributers will be used to reach the sales channels and market. To position our product in the market and to manage our brand, we will build up a marketing team.

In order to serve technical infrastructure for our postsales services, we will build a powerful data center that will be managed by our technology team. There will be a team managing the postsales services channels. We will have partners that will be dealing with the end users. We will sell the necessary IT infrastructure services to our partners as a wholesaler.

There will be different channel structures for the postsales services functions. There will be partner firms that will operate the tracking system, provide the customer service supports, and perform the billing and charging operations. Partners will charge the end users on a monthly subscription basis.

#### 10.2.1 Human

The company will be providing high-tech key turn solutions to its customers and has plans to achieve this goal by hiring talented people with a strong technological background. The organizational structure of the company is shown earlier.

#### 10.2.2 Financial

The company has sufficient financial power to operate in this area. Since all the products or solutions include R&D and high technology and software development, Tubitak Teydep project support is acquired for financing the R&D activities of the company.

#### 10.2.3 Physical

The main office and R&D laboratory of the company is located in Tubitak Techno-Park, Gebze, in order to take the benefits of the tax reduction and low rental costs.

#### 10.2.4 Technological

The company will be providing high-tech key turn solutions to its customers. The company is capable of providing high-tech solutions in

tracking systems by making integrations, combining existing products and developing software to form a new product or solution. Solutions are mainly based on GPS (global positioning system) to determine global coordinates of the objects, and GPRS (general packet radio services) and RF (radio frequency) to transmit the position of an object. Solutions also include supplying extra power to the system, which is very important in landscapes. Different GPS modules, transmitters, and power supplies are used depending on the requirements of the targeted market.

#### 10.2.5 Business Strengths and Weaknesses

Strengths The company's organizational strength comes from its ability to generate new high-tech solutions by using existing products and making new developments by a limited but highly motivated and qualified people. This strength is also supported by tax-free R&D activities for technological projects. Another strength is the customer satisfaction realized via customer-oriented postsales channel structure.

Weaknesses The company's main weakness is a lack of reputation.

# 10.3 Competitive Advantages

The company has a distinguished and valuable technological know-how in this field, which is very difficult to imitate. Although it is possible to reach GPS and GPRS modules or products, it is difficult to form a new product integrating those products and making necessary developments. This approach requires very detailed knowledge of the technology and understanding of the internals of products. Additionally, the company has a strong sales channel structure, creative marketing capabilities, and customer-oriented postsales services.

# 10.4 Scenarios and Opportunities

10.4.1 Positive and Negative Scenarios for Industry

Positive scenarios

• The growing economy of Turkey will also have positive impacts on logistics, transportation, and tourism sectors, which will bring more demand to the tracking products.

 Increase in per capita income and changing trends toward nature will increase the interests for outdoor activities.

#### Negative scenarios

- The crisis in Europe triggers the global economic crisis. This may cause an economic failure in Turkey as well, which may shrink the end-user market.
- Global players can turn into our industry and build solutions by which creating serious competition.
- In case of any failures in GPS technologies, products will be useless.

#### 10.4.2 Business Opportunity

By producing high-tech and value-added unique solutions to end users, we will fill the gap in the tracking market. Easy-to-reach products and map integrated with visual tracking and reporting tools will be our weapons.

- Our financial objective is to get financial support from the government for R&D projects.

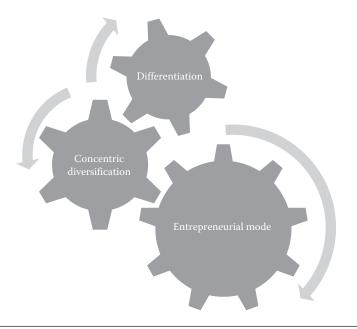

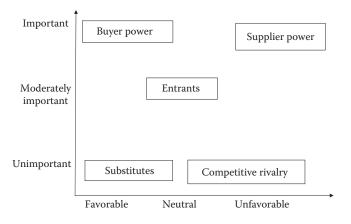


Figure 11.1 Competitive forces.

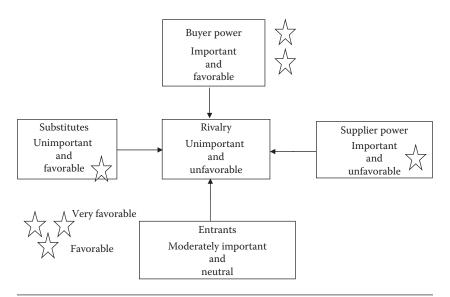


Figure 11.2 Competitive forces status.

- 5. Euro/TL parity increases so high that Turkish companies have price advantages.

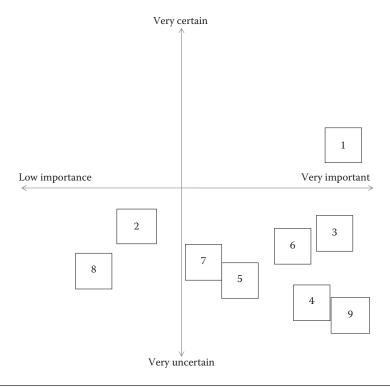


Figure 11.3 Certainty—importance grid.

- 6. There will be strict restrictions for low-quality health-care equipment that may reduce Chinese competitive power.
- 7. Transportation costs from China to Turkey may decrease due to the higher return loads from Turkey to China.
- 8. Russia gives importance to health-care equipment market.
- 9. New developments in medical science allow handicapped patients get well.

By positioning the assumptions resulted from environmental analysis (shown in Figure 11.3), the following list of events are formed, and they are rated based on their importances and probability of occurrences. Accordingly, the list of events that have rates above 3 (shown in Table 11.7) are used for developing alternative scenario definitions.

#### 11.4.2 Positive and Negative Scenarios for Industry

#### Positive scenarios

- Based on events 1 and 2, governments worldwide increase their budget for health-care and social security systems that increase the size of medical market. In addition to this progress, economic growth also improves the sales and profitability.
- Based on event 3, Turkish government gives high incentives to local start-ups in the medical field.
- Based on events 5 and 6, increased €/TL parity and the restrictions on low-quality Chinese products, Turkish brands may have best price/performance ratios that may help them in both local and global competition.

# Negative scenarios

Based on event 7, if Turkey starts exporting to China, transportation companies will be able to find return loads easier for their containers. This less likely case will decrease the transportation costs that may be a threat for Turkish medical companies.

Based on event 8, new player means more competition. Russia currently is not active in the medical field; but if they give importance to this field, it may have a negative effect on especially Turkish companies.

#### 11.4.3 Business Opportunity

High profitability and fewer players may point out the attractiveness of the medical market, but high R&D expenses and wide distribution channels require a great amount of capital for investment. So the market is quite attractive for financially powered big players but quite risky for start-ups.

On one side, there are high-tech global giants and on the other side, there are low-cost Chinese companies. It is not easy to compete with any side, and entry barrier to market is quite high.

As Turkey does not have a developed electronics industry, we need to purchase 70% of inputs from other countries, which makes us dependent on factors that we cannot control. Backward vertical integration is necessary, but it is not easy to realize.

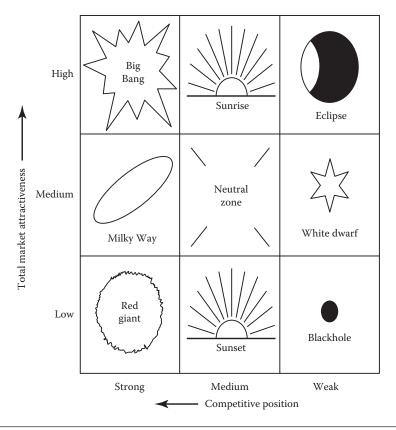


Figure 11.4 Business opportunities.

The first positive scenario can be our Big Bang, in which market attractiveness is quite high and our product performances, costs, technical, and nontechnical competencies and management skills can help us take advantage (shown in Table 11.8) of this opportunity. Figure 11.4 shows the Big Bang as a business opportunity, based on the competitive advantages of the firm that can be used for catching the probable positive scenarios that may happen for the industry.

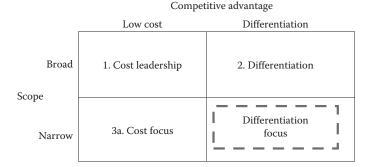


Figure 11.5 Generic competitive strategies.

The major jump for the sales will be by organizing a local dealer network, in which every single dealer should have an annual minimum purchase limit and meet some basic showroom requirements.

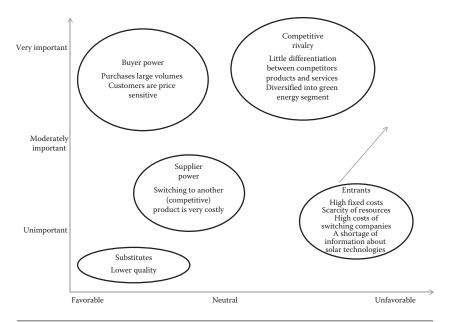


Figure 12.1 Competitive forces.

- As a result of economic instability, new investments may be low. Furthermore, energy and raw material costs would rise, capacity utilization would decline, and prices would surge.

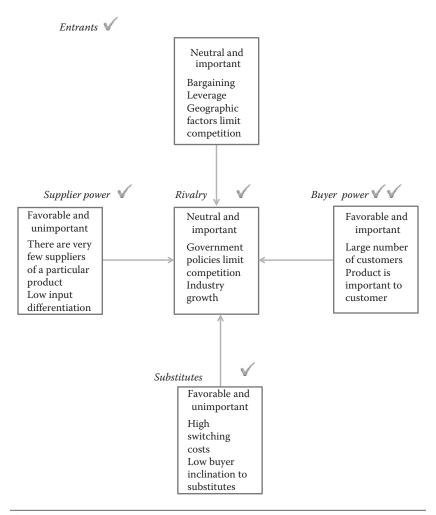


Figure 12.2 Competitive forces status.

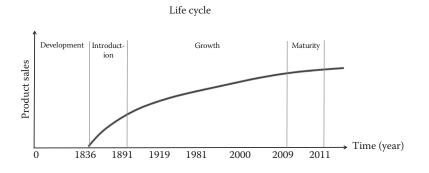


Figure 12.3 Industry life cycle.

# 12.4.2.1 The Big Bang Incentives other than feed-in tariffs for renewable energy investments:

- 99% exemption from annual license fees for the first 8 years of operation
- VAT exemption for domestic equipment for Investment Support Certificate holders
- VAT incentives for R&D activities
- Deduction of R&D expenditures from corporate tax base at a rate of 100%
- Income tax exemption (80% of salary income is eligible for R&D and support personnel), social security premium support for 5 years, and stamp tax exemption

The feed-in tariff for wind power plant is \$0.073/kWh, and this amount can only reach to 0.11 cents with the addition of maximum local production premium. EPDK has granted 209 licenses with a total capacity of 7491 MW, in which 1725 MW of this capacity is in operation while 5765 MW is under construction.

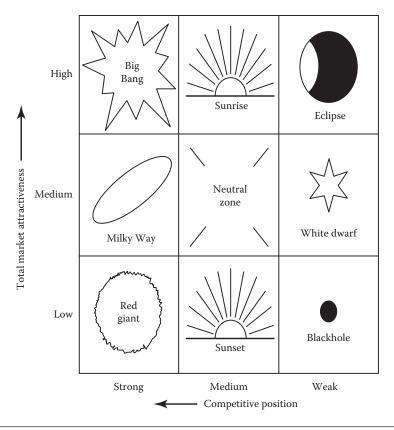


Figure 12.4 Business opportunities.
